AN ACT to amend the public housing law and the administrative code of the city of New York, in relation to penalties for non-compliance of division of housing and community renewal orders

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The public housing law is amended by adding a new section 14-a to read as follows:

§ 14-a. Penalties for non-compliance. Any landlord or owner of a multiple dwelling who fails to comply with any order by the division of housing shall be subject to a fine of not more than five thousand dollars for each instance of non-compliance.

§ 2. Title 26 of the administrative code of the city of New York is amended by adding a new chapter 1 to read as follows:

CHAPTER 1

MISCELLANEOUS

Section 26-101 Penalties for non-compliance.

§ 26-101 Penalties for non-compliance. 1. Any owner of a dwelling unit who fails to comply with any order by the division of housing and community renewal shall be subject to a fine of not more than five thousand dollars for each instance of non-compliance.

2. For purposes of this section:

(a) the term "owner" shall mean and include the owner or owners of the freehold of the premises or lesser estate therein, a mortgagee or vendee in possession, assignee of rents, receiver, executor, trustee, lessee, agent, or any other person, firm or corporation, directly or indirectly in control of a dwelling; and

(b) the term "dwelling unit" shall mean any residential accommodation in a multiple dwelling or private dwelling.

§ 3. This act shall take effect on the sixtieth day after it shall have become a law.
