ordered reprinted as amended and recommitted to said committee

AN ACT to amend the mental hygiene law, in relation to the prescription  
of antidepressant and anti-anxiety medications which have an increased  
risk of suicidal behavior

The People of the State of New York, represented in Senate and Assem-  
bly, do enact as follows:

1 Section 1. The mental hygiene law is amended by adding a new section  
2 7.49 to read as follows:

3 § 7.49 Antidepressant and anti-anxiety medications.

4 (a) The commissioner, in consultation with the commissioner of health,  
5 shall create or utilize existing educational materials regarding the  
6 potential side effects with use of antidepressants or anti-anxiety medi-  
7 cation.

8 (b) Such materials shall be made available to pharmacies registered in  
9 the state, and shall be distributed at the time of dispensing with any  
10 prescribed drug that is identified by the department of health as having  
11 an increased risk of side effects when used. Information disseminated  
12 pursuant to this subdivision may, at the option of the consumer, be  
13 distributed through electronic means.

14 (c) Such material shall also be posted on the websites of the office  
15 and the department of health and shall be provided in language other  
16 than English as deemed appropriate by the commissioners, but shall  
17 include the ten most commonly spoken languages, aside from English, in  
18 the state.

19 (d) The materials required in subdivision (a) of this section shall  
20 include the following:

21 (1) The suicide prevention lifeline telephone number;

22 (2) The suicide prevention website;

1     (3) Relevant information about antidepressants and anti-anxiety medi-  
2     cations and potential side effects of the medication as well as the  
3     physical, behavioral and advanced warning signs of suicide; and

4     (4) Such other information as the commissioner and the commissioner of  
5     the department of health shall determine to be necessary or informative.

6     (e) The office is authorized and directed to promulgate any rules and  
7     regulations and prepare pamphlets necessary to implement the provisions  
8     of this section.

9     § 2. This act shall take effect on the ninetieth day after it shall  
10    have become a law; provided, however, that effective immediately, the  
11    addition, amendment and/or repeal of any rule or regulation necessary  
12    for the implementation of this act on its effective date are authorized  
13    to be made and completed on or before such date.
