- AN ACT to amend the executive law, in relation to establishing the hire a vet grant program; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Article 17-A of the executive law is amended by adding a
2	new section 369-f to read as follows:
3	§ 369-f. Hire a vet grant. 1. Allowance of grant. A municipality shall
4	be allowed a grant equivalent to the credit provided to eligible taxpay-
5	ers in the "hire a vet credit" as established in subdivision twenty-nine
б	of section two hundred ten-B of the tax law, where such municipality
7	hires and employs, for not less than one year and for not less than
8	thirty-five hours each week, a qualified veteran within the state. The
9	municipality may claim the grant in the year in which the qualified
10	veteran completes one year of employment with the municipality.
11	2. Qualified veteran. A qualified veteran is an individual:

1	(a) who served on active duty in the United States army, navy, air
2	force, marine corps, coast guard or the reserves thereof, or who served
3	in active military service of the United States as a member of the army
4	national guard, air national guard, New York guard or New York naval
5	militia; who was released from active duty by general or honorable
6	discharge after September eleventh, two thousand one;
7	(b) who commences employment with the municipality on or after January
8	first, two thousand nineteen, and before January first, two thousand
9	twenty-one; and
10	(c) who certifies by signed affidavit, under penalty of perjury, that
11	he or she has not been employed for thirty-five or more hours during any
12	week in the one hundred eighty day period immediately prior to his or
13	her employment by the municipality.
14	3. Prohibition. A municipality shall not discharge an employee and
15	hire a qualifying veteran solely for the purpose of qualifying for this
16	grant. This section shall not be deemed to amend, modify or supersede
17	any other law which prescribes the qualifications which a person must
18	have to be appointed to a position subject to the civil service law.
19	4. Amount of grant. The amount of the grant shall be ten percent of
20	the total amount of wages paid to the qualified veteran during the
21	veteran's first full year of employment. Provided, however, that, if the
22	gualified veteran is a disabled veteran, as defined in paragraph (b) of
23	subdivision one of section eighty-five of the civil service law, the
24	amount of the grant shall be fifteen percent of the total amount of
25	wages paid to the qualified veteran during the veteran's first full year
26	of employment. The grant allowed pursuant to this subdivision shall not
27	exceed in any year, five thousand dollars for any qualified veteran and
28	fifteen thousand dollars for any qualified veteran who is a disabled
29	veteran.
30	5. Definitions. For purposes of this section, "municipality" means any
31	<u>county, city, town, village or school district.</u>
32	§ 2. This act shall take effect immediately and shall expire and be
33	deemed repealed January 1, 2022.
