AN ACT to amend the executive law and the general municipal law, in relation to prohibiting the provision of assistance in the enforcement of certain United States Executive Orders relating to protecting the nation from foreign terrorist entry, within the state

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Notwithstanding any provision of law to the contrary, no 1 employee or officer of the port authority of New York and New Jersey shall provide any aid, resources, assistance, or support to any federal 4 employee or representative in enforcing the provisions of United States 5 Executive Orders issued on January 27, 2017 and March 6, 2017 regarding 6 Protecting the Nation from Foreign Terrorist Entry into the United 7 States, nor may any resources or facilities of the port authority of New York and New Jersey be used for such purpose.

- § 2. The provisions of this act shall only apply to any employees or 10 officers of the port authority of New York and New Jersey working within the boundaries of the state of New York and shall only apply on properties wholly within the boundaries of the state of New York.
- 13 § 3. The executive law is amended by adding a new section 233 to read 14 as follows:
