AN ACT to amend the general business law, in relation to the fine imposed for certain violations relating to employment agencies

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 190 of the general business law, as amended by chapter 519 of the laws of 2016, is amended to read as follows: 2

§ 190. Penalties for violations. Any person who violates and the officers of a corporation and stockholders holding ten percent or more of the stock of a corporation which is not publicly traded, who knowingly permit the corporation to violate[sections one hundred seventy two, one hundred seventy-three, one hundred seventy-six, one hundred eighty-four, one hundred eighty-four-a, one hundred eighty-five, one hundred eightyfive-a, one hundred eighty-six, or one hundred eighty-seven] any 10 provision of this article [shall be guilty of a misdemeanor and upon conviction shall be subject to a fine [not to exceed two thousand] of 12 <u>not more than</u> five hundred dollars [per violation, or imprisonment for 13 not more than one year, or both, by any court of competent jurisdiction. 14 The violation of any other provision of this article shall be punishable 15 by a fine not to exceed five hundred dollars or imprisonment for not 16 more than thirty days for each day such violation continues; provided, however, that any such person or officer who has been convicted of three or more violations of this article within any period of five years, shall be guilty of a class A misdemeanor. Criminal proceedings based upon violations of these sections shall be instituted by the commission-21 er and may be instituted by any persons aggrieved by such violations.

§ 193. Penalties for violation. Any person violating the provisions of section one hundred ninety-two of this article [shall be guilty of a class A misdemeanor and] shall be subject to a fine [not to exceed one thousand] of not more than five hundred dollars [or imprisonment for not more than one year or both] for each day such violation continues; provided, however, that any such person who has been convicted of three or more violations of this article within any period of five years, shall be guilty of a class A misdemeanor.

9 Criminal proceedings based upon violations may be instituted by the 10 commissioner or may be instituted by any person aggrieved by such 11 violation.

12 § 3. This act shall take effect on the thirtieth day after it shall 13 have become a law.
