AN ACT to amend the elder law, in relation to the interagency coordinating committee for streamlined services for the aging

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Article 2 of the elder law is amended by adding a new title

10	be known as "the interagency coordinating committee for streamlined
11	services for the aging," to be comprised of seventeen members. The
12	director for the state office for the aging or his or her designee shall
13	serve as chairperson. The members shall be the following, or a duly
14	designated representative: the commissioner of health; the commissioner
15	of transportation; the commissioner of housing and community renewal;
16	the commissioner of the office of mental health; the commissioner of the
17	office for people with developmental disabilities; the commissioner of
18	the office of children and family services; the commissioner of the
19	office of temporary and disability assistance; secretary of state; the
20	director of the office of information technology services; and the
21	commissioner of taxation and finance. Six additional members, all of
22	whom shall be aging not-for-profits, organizations, or service providers

serve a term of three years as follows: two by the temporary president 1 2 the senate, two by the speaker of the assembly, one by the minority of 3 leader of the senate, and one by the minority leader of the assembly. 4 Such additional members shall be broadly representative of consumers and 5 providers when making such appointments. Members of the committee shall б receive no salary. 7 2. The committee shall have the following powers and duties: 8 (a) Develop a statewide survey to identify where there are gaps and 9 barriers to access to services for the elderly. The committee shall 10 develop recommendations for the distribution of the survey to reach a representative sample of the senior population in New York to identify 11 trends in areas including, but not limited to, mental health services, 12 13 transportation, public health and housing. 14 (b) Develop a simplified senior application for need-based programs in the state that seniors may qualify for. 15 16 (c) Coordinate with local offices for the aging to supplement the simplified senior application as articulated in paragraph (b) of this 17 subdivision to create regional specific addendums including applications 18 for public transportation, wellness programs, emergency contact forms, 19 20 and other regionally-specific programs. 21 (d) Develop an online application tool to be utilized by a designated lead agency to supply the simplified senior application as articulated 22 in paragraph (b) of this subdivision for consumers on the internet. 23 (e) Make recommendations to the office for data sharing across agen-24 cies with the intent to track enrollment and identify trends in service 25 26 needs. 27 (f) Develop a standard medical expense deduction worksheet for seniors as well as informational materials regarding qualifying expenses for 28 29 certain needs-based programs. 30 (g) Make recommendations regarding simplified certification and 31 re-certification procedures across programs to establish eligibility. 32 (h) Develop informational materials and a public awareness campaign to 33 disseminate general information about the availability of services for the elderly, including recommendations for distributing information to 34 35 families or caregivers. (i) Develop recommendations to target and distribute simplified appli-36 37 cations to New York seniors. 38 3. Nothing in this section shall prohibit the committee or its members from pursuing federal funding to implement any of the provisions in this 39 40 section. 41 4. The committee shall meet as necessary to carry out its functions, 42 powers, and duties, but such meetings shall occur at least once each 43 quarter. 44 5. The committee shall provide a report to the governor, the temporary 45 president of the senate, the speaker of the assembly, and the chairs of 46 the aging committees in the senate and the assembly on or before Septem-47 ber first of each year, beginning in two thousand eighteen. Such report 48 shall summarize the committee's activity during the preceding year and shall detail legislative recommendations appropriate to effectuate the 49 purposes of this section, and any other recommendations for improving 50 51 the provision of services. It shall include information detailing increases in enrollment in needs based programs for seniors administered 52 by the agencies listed in subdivision one of this section. Such report 53 shall also include a proposed agenda consisting of specific issues that 54

55 the committee plans to address during the following fiscal year.
