Introduced by Sen. LAVALLE -- read twice and ordered printed, and when printed to be committed to the Committee on Higher Education -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the education law, in relation to the requirements for a license as a professional land surveyor; and providing for the repeal of certain provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 7206-a of the education law, as added by chapter 987 of the laws of 1971, paragraph 3 of subdivision 1 and subdivision 2 as amended by chapter 32 of the laws of 1981, paragraph 6 of subdivision 1 as amended by chapter 133 of the laws of 1982 and paragraph 8 of subdivision 1 and subdivision 3 as amended by chapter 62 of the laws of 1989, is amended to read as follows:

§ 7206-a. Requirements for a license as a professional land surveyor.  
1. To qualify for a license as a professional land surveyor, an applicant shall fulfill the following requirements:

(1) Application: file an application with the department;

(2) Education: have received an education, including [~~a bachelor's~~] an associate's or higher degree [~~based on a program~~] in land surveying, engineering, math, or related science with fifteen credits in land surveying, in accordance with the commissioner's regulations;

(3) Experience: [~~(a) If the applicant has a bachelor's or higher degree, have at least four years in work satisfactory to the board, provided that the board may accept study beyond the bachelor's degree in partial fulfillment of this requirement; or (b) If the applicant has an associate's degree, have at least six years in work satisfactory to the board provided that the board may accept study beyond the associate's degree in partial fulfillment of this requirement~~] Have practical experience satisfactory to the department and in accordance with the commis-

1 sioner's regulations, provided that the department may accept study  
2 beyond the associate's degree specified in paragraph two of this subdivi-  
3 vision in partial fulfillment of this requirement;

4 (4) Examination: pass an examination satisfactory to the [board]  
5 department and in accordance with the commissioner's regulations;

6 (5) Age: be at least twenty-one years of age;

7 (6) Citizenship or immigration status: be a United States citizen or  
8 an alien lawfully admitted for permanent residence in the United States;

9 (7) Character: be of good moral character as determined by the depart-  
10 ment; and

11 (8) Fees: pay a fee of two hundred twenty dollars to the department  
12 for admission to a department conducted examination and for an initial  
13 license, a fee of one hundred fifteen dollars for each reexamination, a  
14 fee of one hundred thirty-five dollars for an initial license for  
15 persons not requiring admission to department conducted examination, and  
16 a fee of two hundred ten dollars for each triennial registration period.

17 2. For admittance to the fundamentals of surveying examination, the  
18 applicant shall fulfill the education, experience, and examination  
19 requirements in accordance with the commissioner's regulations. Upon the  
20 successful completion of the examination, an identification card as an  
21 "intern land surveyor" shall be issued by the department. The fee for  
22 examination qualification and identification card as an "intern land  
23 surveyor" shall be seventy dollars.

24 2-a. In lieu of the degree and experience requirements specified in  
25 subparagraphs (2) and (3) of subdivision one of this section, eight  
26 years of practical experience in work satisfactory to the board may be  
27 accepted, provided that each full year of college study in engineering  
28 or land surveying satisfactory to the department may at the discretion  
29 of the board be accepted in lieu of one year of the required eight years  
30 of experience.

31 ~~[3. For an identification card as an "intern land surveyor", an appli-~~  
32 ~~cant shall fulfill the requirements of subdivision one of this section,~~

41 § 2. This act shall take effect eighteen months after it shall have  
42 become a law; provided, however that subdivision 2-a of this act shall  
43 expire 8 years after such effective date when upon such date the  
44 provisions of such subdivision shall be deemed repealed.
