AN ACT to amend the navigation law, in relation to pilotage fees on vessels transiting the New York state waters of Long Island Sound or Block Island Sound east of Execution Rocks or Sands Point

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraphs 1 and 2 of paragraph b of subdivision 4 of
2 section 89-b of the navigation law, subparagraph 1 as amended by chapter
3 473 of the laws of 2012 and subparagraph 2 as amended by chapter 339 of
4 the laws of 2007, are amended to read as follows:
5 (1) Upon the effective date of this paragraph and thereafter:
6 All vessels shall pay [~~seven~~] eight dollars and eighty-six cents per
7 pilotage unit; from January first, two thousand [~~thirteen~~] eighteen
8 until January first, two thousand [~~fourteen~~] nineteen all vessels shall
9 pay eight dollars and [~~eleven~~] ninety-five cents per pilotage unit; from
10 January first, two thousand [~~fourteen~~] nineteen until January first, two
11 thousand [~~fifteen~~] twenty, all vessels shall pay [~~eight~~] nine dollars
12 and [~~twenty-seven~~] four cents per pilotage unit; from January first, two
13 thousand [~~fifteen~~] twenty until January first, two thousand [~~sixteen~~]
14 twenty-one all vessels shall pay [~~eight~~] nine dollars and [~~forty-four~~]
15 twenty-two cents per pilotage unit; from January first, two thousand
16 [~~sixteen~~] twenty-one until January first, two thousand [~~seventeen~~] twen-
17 ty-two all vessels shall pay [~~eight~~] nine dollars and [~~sixty~~] forty
18 cents per pilotage unit; on and after January first, two thousand
