- AN ACT to amend the social services law, in relation to lactation counseling services

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (x) of subdivision 2 of section 365-a of the 2 social services law, as added by section 6 of part D of chapter 56 of the laws of 2012, is amended to read as follows: 3 (x)(i) lactation counseling services for pregnant and postpartum women 4 [when such services are ordered by a physician, registered physician assistant, registered nurse practitioner, or licensed midwife and] 5 б 7 provided by a [**certified**] **<u>qualified</u>** lactation [consultant] <u>care</u> provider, as determined by the commissioner of health; provided, howev-8 er, that the provisions of this paragraph shall not take effect unless 9 10 all necessary approvals under federal law and regulation have been 11 obtained to receive federal financial participation in the costs of 12 health care services provided pursuant to this paragraph. Nothing in this paragraph shall be construed to modify any licensure, certification 13 14 or scope of practice provision under title eight of the education law. (ii) For the purposes of this paragraph, the following terms shall 15 16 have the following meanings: (1) "Qualified lactation care provider" shall mean a person who 17 18 possesses current certification from a certification program accredited 19 by a nationally recognized accrediting agency. (2) "Nationally recognized accrediting agency" shall mean the National 20
