AN ACT to amend the penal law, in relation to domestic violence crimes

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The penal law is amended by adding a new article 264 to read as follows:

ARTICLE 264

DOMESTIC VIOLENCE CRIMES

§ 264.00 Domestic violence crimes.

- 1. A person commits a domestic violence crime when he or she intentionally commits or intends to commit a specified offense against a member of the same family or household.

- 3. For purposes of this section, a member of the same family or household shall mean the following individuals:
 - (a) persons related by consanguinity or affinity;
 - (b) persons legally married to one another;
- 33 (c) persons formerly married to one another regardless of whether they 34 still reside in the same household;
- 35 <u>(d) persons who have a child in common regardless of whether such</u>
 36 <u>persons are married or have lived together at any time; or</u>
- 37 (e) unrelated persons who are continually or at regular intervals
 38 living in the same household or who have in the past continually or at
 39 regular intervals lived in the same household.

- 1. When a person is convicted of a domestic violence crime pursuant to this article, and the specified offense is a violent felony offense, as defined in section 70.02 of this chapter, the domestic violence crime shall be deemed a violent felony offense.
- 2. When a person is convicted of a domestic violence crime pursuant to this article and the specified offense is a misdemeanor or a class C. D or E felony, the domestic violence crime shall be deemed to be one category higher than the specified offense the defendant committed, or one category higher than the offense level applicable to the defendant's conviction for an attempt or conspiracy to commit a specified offense, whichever is applicable.
- 3. When a person is convicted of a domestic violence crime pursuant to
 this article and the specified offense is a violation, the domestic
 violence crime shall be deemed an unclassified misdemeanor and the term
 of the definite sentence shall not exceed sixty days.

4. Notwithstanding any other provision of law, when a person is convicted of a domestic violence crime pursuant to this article and the specified offense is a class B felony:

- (a) the maximum term of the indeterminate sentence must be at least six years if the defendant is sentenced pursuant to section 70.00 of this chapter;
- (b) the term of the determinate sentence must be at least eight years if the defendant is sentenced pursuant to section 70.02 of this chapter;
- (c) the term of the determinate sentence must be at least twelve years if the defendant is sentenced pursuant to section 70.04 of this chapter;
- 11 (d) the maximum term of the indeterminate sentence must be at least four years if the defendant is sentenced pursuant to section 70.05 of 12 13 this chapter; and
 - (e) the maximum term of the indeterminate sentence or the term of the determinate sentence must be at least ten years if the defendant is sentenced pursuant to section 70.06 of this chapter.
- 5. Notwithstanding any other provision of law, when a person is convicted of a domestic violence crime pursuant to this article and the 18 19 specified offense is a class A-1 felony, the minimum period of the inde-20 terminate sentence shall be not less than twenty years.
- 21 6. In addition to any of the dispositions authorized by this chapter, the court may require as part of the sentence imposed upon a person 22 convicted of a domestic violence crime pursuant to this article, that 23 24 the defendant complete a program, training session or counseling session 25 directed at domestic violence crime prevention and education, where the court determines such program, training session or counseling session is 27 appropriate, available and was developed or authorized by the court or local agencies in cooperation with organizations serving the affected 28 community.
- 30 § 2. This act shall take effect on the ninetieth day after it shall 31 have become a law.
