AN ACT to direct the metropolitan transportation authority to identify flammable or hazardous materials near above-ground and grade level tracks

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The metropolitan transportation authority, in consultation  
2 with the Long Island Rail Road and other relevant agencies, including  
3 but not limited to the New York city department of transportation and  
4 the state department of transportation, shall conduct a study to examine  
5 the industrial areas located under above-ground LIRR tracks and adjacent  
6 to grade level tracks to identify unsafe and flammable materials that  
7 are exposed to commuter operations.

8 § 2. For purposes of this act:

9 (a) "LIRR" shall mean the Long Island Rail Road; and

10 (b) "grade level" shall mean where a track intersects with a highway  
11 on the same level as the highway.

12 § 3. Such study shall include, but not be limited to:

13 (a) an inspection of the industrial areas located under above-ground  
14 LIRR tracks and adjacent to grade level tracks for the purpose of iden-  
15 tifying materials that may be hazardous or flammable. The size of such  
16 area of inspection shall be determined by the metropolitan transporta-  
17 tion authority;

18 (b) an analysis of potential methods for removal of the hazardous or  
19 flammable materials, if such materials are identified;

20 (c) an analysis of the cost and economic impact of removing such mate-  
21 rials;

22 (d) recommendations on how to maintain areas below or adjacent to such  
23 tracks to keep them free from hazardous or flammable materials; and

24 (e) any other issues related to the safety of such areas as determined  
25 by the chairman of the metropolitan transportation authority.

26 § 4. All departments, divisions, bureaus, commissions, districts or  
27 agencies of the state or any political subdivisions thereof shall, at

1 the request of the chairman of the metropolitan transportation authori-  
2 ty, provide the authority with facilities, assistance and data that will  
3 enable the authority to carry out its powers and duties under this act.

4 § 5. Within one hundred twenty days after the effective date of this  
5 act, the chairman of the metropolitan transportation authority shall  
6 submit a written report to the governor, temporary president of the  
7 senate, speaker of the assembly and mayor of the city of New York, with  
8 the findings and recommendations of the study conducted pursuant to this  
9 act.

10 § 6. This act shall take effect immediately.
