- AN ACT to amend the alcoholic beverage control law, in relation to promoting the education of the human trafficking information and referral hotlines to assist individuals from becoming or freeing themselves from any act of severe forms of sex trafficking

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Legislative findings. Presently, there is no law requiring
2	wine and beer establishments to post a notification regarding the
3	offense of human trafficking. About 80 percent of trafficking victims
4	are often forced into the sex-slave trade industry. In many of these
5	cases, women and men are forced to be hosts or servers in establishments
6	that serve alcohol in bars or entertainment clubs. Furthermore, outreach
7	services are widely unknown to victims of trafficking. The purpose of
8	this act is to promote the education of the federal toll free human
9	trafficking referral hotlines.
10	§ 2. The alcoholic beverage control law is amended by adding a new
11	section 65-e to read as follows:
12	<u>§ 65-e. Posting of signs relating to human trafficking. 1. The</u>
13	authority shall prepare, print and distribute across the state to any
14	person, corporation, partnership, or other business establishment with a
15	license to sell alcoholic beverages for consumption on the premises and
16	any establishment that permits any person to appear on licensed premises
17	in such a manner or attire as to expose to view any portion of the pubic
18	area, anus, vulva or genitals, or any simulation thereof, or permit any
19	female to appear in such a manner or attire as to expose to view any
20	portion of the breast below the top of the areola, a sign or poster
21	meeting the following specifications:
22	(a) Conspicuous lettering stating "Notice on Human Trafficking:
23	Obtaining forced labor or service is a crime under the federal govern-
24	ment. If you or someone you know is a victim of human trafficking, you

4	(b) (i) The sign must be at least eight and one-half inches high and
5	eleven inches wide. The English notice must cover approximately two-
6	thirds of the sign, and Spanish and any other language that the authori-
7	ty deems necessary to display on the notice should cover one-third of
8	the sign.
9	(ii) If the National Human Trafficking Resource Center toll free
10	number or the Trafficking in Persons and Worker Exploitation Task Force
11	Complaint Line number changes, the authority is required to reissue the
12	sign or poster with the change within thirty days to any person, corpo-
13	ration, partnership, other business establishment with a license to sell
14	alcoholic beverages for consumption on the premises and any establish-
15	ment that permits any person to appear on licensed premises in such a
16	manner or attire as to expose to view any portion of the pubic area,
17	anus, vulva or genitals, or any simulation thereof, or permit any female
18	to appear in such a manner or attire as to expose to view any portion of
19	the breast below the top of the areola.
20	(c) Any person, corporation, partnership, or other business establish-
21	ment with a license to sell alcoholic beverages for consumption on the
22	premises and any establishment that permits any person to appear on
23	licensed premises in such a manner or attire as to expose to view any
24	portion of the pubic area, anus, vulva or genitals, or any simulation
25	thereof, or permit any female to appear in such a manner or attire as to
26	expose to view any portion of the breast below the top of the areola,
27	shall display, in an upright position and in a conspicuous place where
28	it can be easily read by clientele and employees of the establishment,
29	such sign or poster upon receiving it from the authority.
30	2. Any person, corporation, partnership, or other business establish-
31	ment with a license to sell alcoholic beverages for consumption on the
32	premises and any establishment that permits any person to appear on
33	licensed premises in such a manner or attire as to expose to view any
34	portion of the pubic area, anus, vulva or genitals, or any simulation
35	thereof, or permit any female to appear in such a manner or attire as to
36	expose to view any portion of the breast below the top of the areola,
37	who violates the provisions of this section shall be subject to a civil
38	penalty, not to exceed one hundred dollars for each day of violation.
39	§ 3. This act shall take effect immediately.
