AN ACT to amend the education law, in relation to registered dental assisting

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The article heading of article 133 of the education law, as added by chapter 987 of the laws of 1971, is amended to read as follows:

DENTISTRY [AND], DENTAL HYGIENE, AND

## REGISTERED DENTAL ASSISTING

§ 2. Section 6600 of the education law, as added by chapter 987 of the laws of 1971, is amended to read as follows:

- § 6600. Introduction. This article applies to the professions of dentistry [and], dental hygiene, and registered dental assisting. The general provisions for all professions contained in article one hundred thirty of this title apply to this article.
- § 3. Section 6603 of the education law, as amended by chapter 393 of the laws of 1999, is amended to read as follows:
- § 6603. State board for dentistry. A state board for dentistry shall 13 14 be appointed by the board of regents on recommendation of the commis-15 sioner for the purpose of assisting the board of regents and the depart-16 ment on matters of professional licensing and professional conduct in 17 accordance with section sixty-five hundred eight of this title. The board shall be composed of not less than thirteen dentists licensed in this state for at least five years, not less than three dental hygien-19 ists licensed in this state for at least five years, and not less than 20 one [certified] registered dental assistant licensed in this state for 21 22 at least one year. An executive secretary to the board shall be appointed by the board of regents on recommendation of the commissioner 24 and shall be a dentist licensed in this state.
- 25 § 4. Section 6608 of the education law, as amended by chapter 239 of 26 the laws of 2013, is amended to read as follows:
- 27 § 6608. Definition of practice of [certified] registered dental 28 assisting. The practice of [certified] registered dental assisting is

defined as providing supportive services to a dentist in [his/her] his or her performance of dental services authorized under this article. Such support shall include providing patient education, taking prelimi-3 nary medical histories and vital signs to be reviewed by the dentist, placing and removing rubber dams, selecting and prefitting provisional crowns, selecting and prefitting orthodontic bands, removing orthodontic 7 arch wires and ligature ties, placing and removing matrix bands, taking impressions for study casts or diagnostic casts, removing periodontal 9 dressings, and such other dental supportive services authorized by the 10 dentist consistent with regulations promulgated by the commissioner, provided that such functions are performed under the direct personal 11 supervision of a licensed dentist in the course of the performance of 12 13 dental services. Such services shall not include diagnosing and/or 14 performing surgical procedures, irreversible procedures or procedures 15 that would alter the hard or soft tissue of the oral and maxillofacial 16 area or any other procedures determined by the department. The practice 17 [certified] registered dental assisting may be conducted in the office of any licensed dentist or in any appropriately equipped school 18 public institution but must be done under the direct personal super-19 20 vision of a licensed dentist. Direct personal supervision, for purposes 21 of this section, means supervision of dental procedures based on 22 instructions given by a licensed dentist in the course of a procedure who remains in the dental office where the supportive services are being 23 performed, personally diagnoses the condition to be treated, personally 24 25 authorizes the procedures, and before dismissal of the patient, who 26 remains the responsibility of the licensed dentist, evaluates the 27 services performed by the **registered** dental assistant. Nothing herein 28 authorizes a registered dental assistant to perform any of the services 29 functions defined as part of the practice of dental hygiene in 30 accordance with the provisions of subdivision one of section sixty-six 31 hundred six of this article, except those functions authorized pursuant 32 to this section. All dental supportive services provided in this section may be performed by currently registered dental hygienists either under 33 34 a dentist's supervision, as defined in regulations of the commissioner, 35 or, in the case of a registered dental hygienist working for a hospital 36 as defined in article twenty-eight of the public health law, pursuant to 37 collaborative arrangement with a licensed dentist in accordance with 38 subdivision one of section sixty-six hundred six of this article. collaborative arrangement shall not obviate or supersede any law or 39 40 regulation which requires identified services to be performed under the 41 personal supervision of a dentist.

- § 5. Section 6608-a of the education law, as added by chapter 494 of the laws of 1994, is amended to read as follows:
- § 6608-a. Practice of [certified] registered dental assisting and use of title "[certified] registered dental assistant". Only a person certified under section sixty-six hundred eight-b of this article or exempt pursuant to section sixty-six hundred ten of this article shall practice [certified] registered dental assisting. Only a person certified pursuant to section sixty-six hundred eight-b of this article shall use the title "[certified] registered dental assistant".
- § 6. Section 6608-b of the education law, as added by chapter 494 of the laws of 1994, subdivision 4 as amended by chapter 300 of the laws of 2006 and subdivision 5 as amended by chapter 565 of the laws of 1995, is amended to read as follows:
- § 6608-b. Requirements for certification as a [certified] registered dental assistant. To qualify for certification as a [certified] registered

tered dental assistant, an applicant shall fulfill the following
requirements:

- (1) Application: file an application with the department;
- (2) Age: be at least [seventeen] eighteen years of age;
- 5 (3) Fees: pay a fee of forty-five dollars to the department for 6 initial certification and a fee of fifty dollars for each triennial 7 registration period;
  - (4) Education and experience: (A) have received a high school diploma, or its equivalent, and (B) have successfully completed, in accordance with the commissioner's regulations, (i) an approved one-year course of study in dental assisting in a degree-granting institution or a board of cooperative educational services program which includes at least two hundred hours of clinical experience, or an equivalent approved course of study in dental assisting in a non-degree granting institution which shall not be a professional association or professional organization or (ii) an alternate course of study in dental assisting acceptable to the department which shall be provided by a degree-granting institution or a board of cooperative educational services program which includes at least one thousand hours of relevant work experience; [and]
- 20 (5) Examination: pass an examination <u>in dental assisting</u> given by an 21 organization which administers <u>such</u> examinations [<del>for certifying dental</del> 22 <del>assistants</del>] and which is acceptable to the department[-]; and
- 23 <u>(6) Character: be of good moral character as determined by the depart-</u>
  24 <u>ment.</u>
  - § 7. This act shall take effect immediately.
