AN ACT to amend the navigation law, in relation to the authorized reimbursement rate paid to governmental entities for local navigation enforcement expenditures

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 79-b of the navigation law, as amended by section 1 of part D of chapter 109 of the laws of 2010, is amended to read as follows:

3. The amount of state aid to be allocated to eligible governmental entities pursuant to this article shall be determined by the commissioner as hereinafter provided. The commissioner shall determine the percentage proportion which the authorized expenditures of each individ-7 ual entity, not exceeding four hundred thousand dollars for each county including municipalities therein, shall bear to the total authorized 10 expenditures of all entities. Such percentage proportion shall then be applied against an amount equal to one-half of the total of the amount 11 12 received by the state in each preceding program year in vessel registration fees as provided in section twenty-two hundred fifty-one of the 13 vehicle and traffic law, less no more than thirty percent, subject to 14 15 appropriation, which may be used by the commissioner and the commission-16 er of motor vehicles for administrative costs of the program, including 17 training and equipment, and by the department of environmental conserva-18 tion, the division of state police and other state agencies, subject to the approval of the commissioner, for the purposes of this article, plus 20 the entire amount received pursuant to subdivision nine of section
