AN ACT to amend the real property tax law, in relation to allowing former National Guard members to apply for the veterans alternative exemption

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (e) of subdivision 1 of section 458-a of the real property tax law, as amended by chapter 384 of the laws of 2008, is amended to read as follows:

(e) "Veteran" means a person (i) who served in the active military, 4 5 naval, or air service during a period of war, or who was a recipient of the armed forces expeditionary medal, navy expeditionary medal, marine 7 corps expeditionary medal, or global war on terrorism expeditionary medal, and who was discharged or released therefrom under honorable conditions, (ii) who was employed by the War Shipping Administration or 10 Office of Defense Transportation or their agents as a merchant seaman 11 documented by the United States Coast Guard or Department of Commerce, 12 or as a civil servant employed by the United States Army Transport 13 Service (later redesignated as the United States Army Transportation 14 Corps, Water Division) or the Naval Transportation Service; and who 15 served satisfactorily as a crew member during the period of armed 16 conflict, December seventh, nineteen hundred forty-one, to August 17 fifteenth, nineteen hundred forty-five, aboard merchant vessels in 18 oceangoing, i.e., foreign, intercoastal, or coastwise service as such terms are defined under federal law (46 USCA 10301 & 10501) and further 19 to include "near foreign" voyages between the United States and Canada, 20 21 Mexico, or the West Indies via ocean routes, or public vessels in oceangoing service or foreign waters and who has received a Certificate of 23 Release or Discharge from Active Duty and a discharge certificate, or an 24 Honorable Service Certificate/Report of Casualty, from the department of defense, (iii) who served as a United States civilian employed by the 26 American Field Service and served overseas under United States Armies and United States Army Groups in world war II during the period of armed 27

§ 2. This act shall take effect immediately.

18
