AN ACT to amend the penal law, in relation to requiring social media and search engine reviews prior to the delivery of a rifle or shotgun

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The penal law is amended by adding a new section 400.20 to 2 read as follows:

3 § 400.20 Social media account and search engine history review prior to 4 the delivery of a rifle or shotgun.

5 <u>1. Prior to the delivery of any rifle or shotgun sold by a licensed</u> 6 dealer to any person, the purchaser shall consent to have his or her 7 social media accounts and search engine history reviewed and investi-8 gated by the police authority of the locality where such sale is made. 9 After completion of the review pursuant to subdivision two of this 10 section, the purchaser shall provide the licensed dealer with proof of 11 his or her approval to purchase such rifle or shotgun.

12 2. In order to ascertain whether any social media account or search 13 engine history of a purchaser of a rifle or shotgun presents any good cause for the denial of such purchase, the police authority of the 14 15 locality where such sale is made shall, after obtaining the purchaser's 16 consent pursuant to subdivision one of this section, and obtaining any 17 log-in name, password or other means for accessing a personal account, service, or electronic communications device necessary to review such 18 purchaser's social media accounts and search engine history, review a 19 purchaser's social media accounts for the previous three years and 20 21 search engine history for the previous year and investigate posts or 22 searches related to (i) commonly known profane slurs or biased language 23 used to describe the race, color, national origin, ancestry, gender, 24 religion, religious practice, age, disability or sexual orientation of a person; (ii) threatening the health or safety of another person; (iii) 25 an act of terrorism; or (iv) any other issue deemed necessary by the 26 27 police authority. For the purposes of this section, "social media accounts" shall only include Facebook, Snapchat, Twitter and Instagram, 28
