AN ACT to amend the public service law, in relation to the community solar pilot program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The public service law is amended by adding a new section 2 66-o to read as follows:
- § 66-o. Community solar pilot program. 1. The commission shall establish a New York state pilot program promoting the use of community solar energy.
- 6 2. The commission shall oversee the implementation of the pilot
  7 program and shall issue an order of the commission authorizing the
  8 construction of a solar installation.
- 9 <u>3. The commission shall invite consumers to participate in the program</u>
  10 <u>as subscribers, provided that:</u>
- a. the commission shall set a subscription schedule, including the price per watt to subscribe and the percentage of the total installation each subscription level shall represent;
- b. subscribers shall make a one time payment to the commission and, in return, subscribers shall be paid a quarterly dividend for the energy generated by the watts covered by their subscription level;
- 17 <u>c. a consumer shall be paid on a quarterly basis based on the consum-</u>
  18 er's subscription level;
- 19 <u>d. the commission shall set a maximum number of subscriptions at each</u> 20 <u>level; and</u>
- 21 <u>e. the minimum price per subscription shall not exceed five hundred</u> 22 <u>dollars.</u>

1 <u>4. All energy generated by the solar installation shall be sold back</u> 2 <u>to an investor-owned utility.</u>

- 5. One percent of all payments due to subscribers shall be held by the commission to pay for the capital investment into the original solar installation. After the original installation has been paid in full, the one percent held by the commission shall be used to fund new solar installations in the same manner.
- 8 <u>6. The state shall retain ownership of the solar installation and of</u> 9 <u>any renewable energy credits generated by the installation.</u>
- 10 <u>7. Subscribers shall be paid for energy generated at the retail rate</u>
  11 and not at the avoided-cost rate.
- 12 <u>8. The maximum size of the installation shall be two thousand kilo-</u>
  13 watts.
- 9. Subscriptions may not be resold to any entity other than the state.
- 15 § 2. This act shall take effect immediately.
