AN ACT to amend the social services law, in relation to reporting of youth placed in foster care settings and recruitment of foster parents

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 17 of the social services law is amended by adding a new subdivision (1) to read as follows:

(1) submit a report to the governor, the speaker of the assembly and the temporary president of the senate beginning December thirty-first, two thousand twenty, and quarterly thereafter, regarding youth placed in foster care settings and the recruitment of foster parents. Such report 7 shall be made publicly available online and shall provide information, 8 as required pursuant to this subdivision, aggregated by local social services districts and foster care settings. For the purposes of this 10 <u>subdivision</u>, <u>foster care settings shall include</u>, <u>but not be limited to</u>,

foster boarding homes, approved relative homes, group homes, group residences, agency operated boarding homes, supervised independent living arrangements, therapeutic foster care and child care institutions. The report shall include, but not be limited to, the following information:

- (i) the total number of youth placed in a foster care setting at the time of the report, as well as a comparison to the total number of youth in care since the previous report was submitted;
- 8 (ii) the reasons why such youth have been placed in a foster care 9 setting, with the total number of youth per category at the time of the 10 report. Such reasons shall include, but not be limited to, voluntary placement pursuant to section three hundred fifty-eight-a of this chap-11 ter, a termination of parental rights pursuant to section three hundred 12 13 eighty-four-b of this chapter, placements pursuant to articles ten and 14 ten-C of the family court act, or pursuant to a contract, grant or other agreement with the federal government; 15
 - (iii) to the extent such information is available, the total number of youth placed in a foster care setting at the time of the report that are in need of or receiving specialized services, either due to a mental health illness or another disorder that may require additional supports and services, including specialized educational services;
- 21 <u>(iv)</u> to the extent such information is available, how many youth at 22 the time of the report have been previously placed in a foster care 23 <u>setting in the state;</u>
- 24 (v) the total number of foster families that are currently certified 25 in the state at the time of the report and whether that number has 26 increased or decreased since the previous report was submitted;
- 27 (vi) how many children and/or families have received preventive
 28 services through a local social services district, and of those children
 29 and/or families, how many youth were successfully kept out of foster
 30 care due to such services within the last calendar year for the initial
 31 report, and then since the previous report was submitted for all subsequent reports;
- 33 (vii) the total number of placement options that have been certified 34 as a qualified residential treatment program, as defined by 42 USCS § 35 672; and
- 36 (viii) the efforts the state has taken to recruit and retain foster 37 parents in the state.
- 38 § 2. This act shall take effect immediately.
