AN ACT to amend the vehicle and traffic law, in relation to "I Support Music Education" distinctive plates; and to amend the state finance law, in relation to establishing the "I support music education" fund

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 "I support music education" fund. 1. There is hereby estab-95-j. 2 lished in the joint custody of the commissioner of taxation and finance and the comptroller a fund to be known as the "I support music educa-3 4 tion" fund. 5 2. Such fund shall consist of all revenues received pursuant to б section four hundred four-ff of the vehicle and traffic law, and all other moneys appropriated, credited or transferred thereto from any other fund or source pursuant to law. Nothing contained in this section 7 8 9 shall prevent the state from receiving grants, gifts or bequests for the purposes of the fund as defined in this section and depositing them into 10 11 the fund according to law. 2-a. On or before the first day of February each year, the comptroller 12 13 shall certify to the governor, temporary president of the senate, speak-14 er of the assembly, chair of the senate finance committee and chair of 15 the assembly ways and means committee, the amount of money deposited in 16 the "I support music education" fund during the preceding calendar year 17 as the result of revenue derived pursuant to section four hundred fourff of the vehicle and traffic law and from grants, gifts and bequests. 18 19 3. Monies of the fund shall be expended only for music education 20 projects approved by the department of education in New York state. 21 4. Monies shall be payable from the fund on the audit and warrant of 22 the comptroller on vouchers approved and certified by the commissioner 23 of education. 24 § 3. 1. A distinctive plate established pursuant to section 404-ff of 25 the vehicle and traffic law shall only be designed, produced and issued 26 upon the delivery to the department of motor vehicles of a surety bond 27 in the amount of six thousand dollars, which shall be executed by a surety company authorized by the department of financial services to transact business in this state. Provided, however, that if the commis-28 29 30 sioner of motor vehicles shall have received prior to plate design, 31 production and issuance at least two hundred orders for such distinctive 32 plate together with the additional annual service charge applicable to 33 each such order, which shall be non-refundable, no such surety bond shall be required. All service charges collected pursuant to this 34 35 section shall be deposited pursuant to the provisions of section 404-oo 36 of the vehicle and traffic law to the credit of the department of motor 37 vehicles distinctive plate development fund established by section 95-j 38 of the state finance law and shall be used for the design, production, 39 advertising and distribution of distinctive license plates in accordance 40 with such section 95-j. 41 If, upon the expiration of two years following the date upon which 2. 42 distinctive plates in the series are first available for sale two 43 hundred or more sets of such plates are sold, a bond delivered pursuant 44 to this section shall be discontinued. If fewer than two hundred sets of 45 such plates are sold by such time, the department of motor vehicles 46 shall be entitled to recover against the bond in an amount proportionate 47 to such shortfall.

48 § 4. This act shall take effect immediately; provided, however, that 49 sections one and two of this act shall take effect on the one hundred 50 eightieth day after it shall have become a law; and provided further, 51 that effective immediately, the addition, amendment and/or repeal of any 52 rule or regulation necessary for the implementation of this act on its 53 effective date are authorized and directed to be made and completed on 54 or before such effective date.
