AN ACT to amend the insurance law, in relation to the collateral estoppel effect of issues decided by certain arbitrators

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 5106 of the insurance law is amended by adding a 2 new subsection (e) to read as follows:

3 (e) With respect to an action for serious personal injury permissible
4 under section five thousand one hundred four of this article, the award
5 or decision of an arbitrator or master arbitrator rendered pursuant to
6 subsection (c) of this section shall not constitute a collateral estop7 pel of the issues arbitrated.

§ 2. This act shall take effect immediately.
