Introduced by M. of A. CUSICK -- read once and referred to the Committee on Corporations, Authorities and Commissions

AN ACT to amend the New York city health and hospitals corporation act, in relation to the financing of acute care or emergency room facilities

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 6 of section 1 of chapter 1016 of the laws of 1969, constituting the New York city health and hospitals corporation act, is amended by adding a new subdivision 8 to read as follows:

- 8. The corporation shall spend a minimum of five percent of the capital budget and five percent of the operating budget in each borough.
- § 2. Subdivision 1 of section 4 of section 1 of chapter 1016 of the laws of 1969, constituting the New York city health and hospitals corporation act, is amended to read as follows:
- 9 1. A corporation, to be known as the "New York city health and hospitals corporation, " is hereby created. Such corporation shall be a body 10 corporate and politic constituting a public benefit corporation. It 11 shall be administered by a board of directors consisting of sixteen 12 13 members, constituted as follows: five directors shall be the administra-14 tor, the commissioner appointed by the mayor as chief administrative 15 officer of the health functions of the administration, the director of 16 community mental health services of the administration, the administrator of human resources of the city, and the deputy mayor-city adminis-17 trator of the city, or their successors, all serving ex-officio; ten 18 19 directors shall be appointed by the mayor, five of whom shall be desig-20 nated by the city council of the city of New York and shall include a 21 representative from each of the five boroughs; and the remaining director shall be the chief executive officer of the corporation. Such chief 23 executive officer shall be chosen by the aforementioned fifteen direc-24 tors from persons other than themselves and shall serve at the pleasure

1 of the board. The terms of the ten directors first appointed by the 2 mayor, other than those serving ex-officio shall be as follows:

- 3 Two shall serve for terms of one year each, one of whom shall have 4 been designated by the city council;
- 5 Two shall serve for terms of two years each, one of whom shall have 6 been designated by the city council;
- Two shall serve for terms of three years each, one of whom shall have been designated by the city council;
- 9 Two shall serve for terms of four years each, one of whom shall have 10 been designated by the city council;
- 11 Two shall serve for terms of five years each, one of whom shall have 12 been designated by the city council;
- 13 thereafter their successors shall serve for terms of five years each.
- 14 The mayor shall fill any vacancy which may occur by reason of death,
- 15 resignation or otherwise in a manner consistent with the original
- 16 appointment. Directors may be removed by the mayor for cause, but not
- 17 without an opportunity to be heard.
- 18 § 3. This act shall take effect immediately.
