AN ACT to amend the public health law, in relation to epinephrine autoinjectors in schools

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The public health law is amended by adding a new section 2 3000-cc to read as follows:
- § 3000-cc. Epinephrine in schools. 1. For purposes of this section:
- 4 (a) "Anaphylaxis" means a potentially life-threatening hypersensitivi-5 ty or allergic reaction to a substance.
- i. Symptoms of anaphylaxis may include shortness of breath, wheezing,
   difficulty breathing, difficulty talking or swallowing, hives, itching,
   swelling, shock, or asthma.
- 9 <u>ii. Causes of anaphylaxis may include, but are not limited to, insect</u>
  10 <u>stings or bites, foods, drugs, and other allergens, as well as idiopath-</u>
  11 <u>ic or exercise-induced anaphylaxis.</u>
- 12 (b) "Trained personnel" with respect to an elementary or secondary
  13 school shall mean an individual:
- i. who has been designated by the principal (or other appropriate administrative staff) of the school to administer epinephrine on a voluntary basis outside their scope of employment;
- 17 <u>ii. who has received training in the administration of epinephrine;</u>
  18 <u>and</u>
- 19 <u>iii. whose training in the administration of epinephrine meets appro-</u>
  20 <u>priate medical standards.</u>
- 21 2. (a) Each school shall train school personnel to administer epineph-
- 22 rine to any student of the school reasonably believed to be suffering
- 23 <u>from anaphylaxis</u>.

(b) The minimum training provided by each school in the administration 1 2 of epinephrine shall include but not be limited to:

- 3 i. Techniques for recognizing circumstances, signs, and symptoms of anaphylaxis; and
- 5 ii. Standards and procedures for proper storage and emergency use of 6 epinephrine auto-injectors.
- 7 3. Each school shall maintain at least two epinephrine auto-injectors 8 (epi-pens) in separate, secure locations that are easily accessible by 9 the relevant trained personnel of the school for the purpose of adminis-10 tration to any student of the school reasonably believed to be suffering 11 from anaphylaxis.
- 4. Each school is required to have in place a plan for having on the premises of the school during all operating hours, one or more individuals who are trained personnel in the administration of epinephrine. 14
- 5. Each school shall send notification home at the beginning of the 15 16 school year to all parents and/or guardians informing them that an epinephrine auto-injector could be administered to their child in the 17 18 event of an anaphylactic reaction.
- 19 6. School officials shall obtain epi-pens from the appropriate medical 20 professionals, but a prescription is not required for their adminis-21 tration.
- 7. School officials shall call 911 emergency services as soon as safe-22 ly possible after administering an epi-pen. 23
- 24 8. Schools and/or staff members who are otherwise in compliance with 25 the requirements of this section shall not be held liable for the reasonable and good faith administration of the epi-pen pursuant to this 27
- § 2. This act shall take effect on the ninetieth day after it shall 28 29 have become a law.
