AN ACT to amend the social services law, in relation to requiring day care centers and public schools to contact a child's parent or guardian if they are absent

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The social services law is amended by adding a new section 2 390-aa to read as follows:
- § 390-aa. Child well-being check. 1. For purposes of this section, the following terms shall have the following meanings:
- 5 <u>(a) "Absent" or "absence" shall mean any child who is expected to be</u>
 6 <u>present for day care services or school who has not arrived at the sche-</u>
 7 <u>duled drop-off time.</u>
- 8 (b) "Child day care provider" shall have the same meaning as defined
 9 in paragraph (b) of subdivision one of section three hundred ninety of
 10 this title.
- 11 (c) "Group family day care home" shall have the same meaning as 12 defined in paragraph (d) of subdivision one of section three hundred 13 ninety of this title.
- 14 <u>(d) "Family day care home" shall have the same meaning as defined in</u>
 15 <u>paragraph (e) of subdivision one of section three hundred ninety of this</u>
 16 <u>title.</u>
- 17 <u>(e) "School age child care" shall have the same meaning as defined in</u>
 18 paragraph (f) of subdivision one of section three hundred ninety of this
 19 title.
- 20 2. (a) All child day care providers, school age child care programs,
 21 group family day care homes and family day care homes within the state
 22 shall be required to contact a child's parent or guardian in the event
 23 such child is absent on a given day, when prior notice of such child's

- 3 (b) Such day care providers, programs or homes shall contact such 4 parent or guardian within one hour after recording that a child is 5 absent on such day.
- 6 3. (a) All public schools within the state shall be required to
 7 contact a child's parent or guardian in the event such child is absent
 8 on a given day, when prior notice of such child's absence has not been
 9 provided, to confirm such child's absence is expected and the parent or
 10 guardian is aware of such absence.
- 11 (b) Such schools shall contact such parent or guardian within one hour 12 after recording that a child is absent on such day.
- 13 § 2. This act shall take effect immediately.
