AN ACT to amend the insurance law and the public health law, in relation to permitting pregnant women to enroll in the state health insurance exchange at any time without penalty

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Section 3217-c of the insurance law is amended by adding a
2	new subsection (d) to read as follows:
3	(d) An insurer, subject to the provisions of this article, a corpo-
4	ration organized pursuant to article forty-three of this chapter, or a
5	licensed maintenance organization under article forty-four of the public
б	health law, that issues a health insurance policy or contract that
7	provides eligibility for a special enrollment period shall allow for the
8	enrollment of a pregnant individual at any time after the commencement
9	of the pregnancy, as certified by a health care practitioner licensed
10	pursuant to title eight of the education law acting within the scope of
11	his or her practice. Such health insurance policy or contract shall not
12	impose a fee or other penalty for special enrollment of the pregnant
13	individual. Coverage shall be effective as of the first of the month in
14	which the individual receives certification of the pregnancy.
15	§ 2. The public health law is amended by adding a new section 2509-a
16	to read as follows:
17	<u>§ 2509-a. Special enrollment; pregnancy. An insurer, subject to the</u>
18	provisions of article thirty-two of the insurance law, a corporation
19	organized pursuant to article forty-three of the insurance law, or a
20	licensed maintenance organization under article forty-four of this chap-
