WHEREAS, In June of 2017, Varflex Corporation achieved ISO 9001:2015 registration for the manufacture of coated and uncoated electrical insulating sleeving made from fiberglass and other filaments as well as twisting and plying of silica and synthetic fibers; and

WHEREAS, Varflex Corporation's sleeveings are used in various electrical applications such as motors, generators, transformers, stators and actuators; additionally, they are found in military, medical, food processing and many other applications; and

WHEREAS, A full-line electrical insulating sleeving manufacturer, Varflex Corporation does its own braiding, enabling the company to maintain a higher level of quality control, reduce lead times and assures its customers of a consistent, reliable product; and

WHEREAS, Furthermore, Varflex Corporation does its own twisting, plying, and yarn winding; and

WHEREAS, Over its distinguished 95-year history, Varflex Corporation has demonstrated continuous service to the residents and communities which it serves; and
