WHEREAS, Special Olympics New York has offered children and adults with intellectual disabilities the opportunity to participate in Olympic type sports for nearly five decades; and

WHEREAS, Today, with more than 61,000 athletes registered in New York State, Special Olympics New York is the largest program in the United States and one of the largest in the world; and

WHEREAS, Remaining true to its mission, Special Olympics New York provides year-round sports training and athletic competition in a variety of Olympic-style sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and participate in a sharing of gifts, skills and friendship with their families, other Special Olympics athletes and the community; and

WHEREAS, The success of Special Olympics New York is in direct correlation to the efforts of its dedicated staff and volunteers, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and
