COMMENDING Rome Free Academy upon the occasion of celebrating its 150th commencement on June 29, 2019

WHEREAS, Established in the 1840s, Rome Academy was a privately owned school which charged tuition; in 1869, a union free school district with a Board of Education was created, and the name was changed to Rome Free Academy; and

WHEREAS, For 150 years, Rome Free Academy has strived to ensure that all of its students have access to a high-quality education which prepares them for the rigors of college and the workforce; and

WHEREAS, The steadfast and unyielding commitment of parents, educators and administrators to provide the highest quality education for students has become the hallmark and tradition of Rome Free Academy; and

WHEREAS, Rome Free Academy is proudly aware of its distinguished past, eager to fulfill its present commitment to parents, students and the community, and planning with vision and purpose for the ebb and swell of growth and change it will encounter in the years to come; now, therefore, be it
