WHEREAS, For his courageous service during these operations, Paul B. Struys, Jr. was awarded the National Defense Service Medal, Southwest Asia Service Medal with a Bronze Star device, and both the Army Achievement and Commendation Medal; and

WHEREAS, Upon the completion of his military service on July 22, 1991, with the rank of Sergeant, Paul B. Struys, Jr. returned to New York, and worked for the local YMCA, Price Chopper and the Charlton Highway Department; and

WHEREAS, Devoted to his fellow veterans, he was a vital member of Veterans of Foreign Wars Post 358 and Rolling Thunder, New York Chapter No. 5; and

WHEREAS, Paul B. Struys, Jr. truly loved life and had the uncanny ability to make everyone laugh; he enjoyed spending time with his longtime partner, Christine Wojtowecz, and his two sons, Jonpaul and Joseph A. Struys, and took great pleasure in working on both the farm and his motorcycles; and

WHEREAS, Paul B. Struys, Jr. died on November 14, 2008, at the age of 41; and

WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize

that no greater debt is owed than that owed to those who gave their lives for their beloved Nation and to those who continue to be missing in action; and

WHEREAS, Having exhibited his patriotism both at home and abroad, Paul B. Struys, Jr. demonstrated his love for his country and merits forevermore the highest respect of his State and Nation; and
