WHEREAS, The success of the Pride Center of the Capital Region is in direct correlation to the efforts of volunteers like Willow Harris, whose involvement is, and always has been, characterized by an impressive commitment, an unbridled enthusiasm, and an uncompromising standard of excellence in all endeavors on behalf of the organization and the community it serves; and
