WHEREAS, Upon the completion of his military service on May 25, 1946, Donald John Keeler returned to the Capital District and was employed as a Machinist in the State of New York; and

WHEREAS, On December 24, 1947, Donald John Keeler married the former Joyce Bentley of Arlington, Vermont; they relocated to Maine in 1975, where the couple raised two sons, Zane and Jay, and two daughters, Holly and Enid; he was the loving grandfather of seven grandchildren and three great-grandchildren; and

WHEREAS, Active in his community, Donald John Keeler was a man of many interests; he held a pilot's license for many years and was a licensed ham radio operator; also passionate about nature, he was a beekeeper with a love of animals and birds; and

WHEREAS, Donald John Keeler died on March 4, 2005, at the age of 83; and

WHEREAS, Residents of this great State must never forget the courage with which these men and women served their country, and must recognize that no greater debt is owed than that owed to those who gave their lives for their beloved Nation and to those who continue to be missing in action; and

WHEREAS, Having exhibited his patriotism both at home and abroad, Donald John Keeler demonstrated his love for his country and merits forevermore, the highest respect of his State and Nation; and

WHEREAS, Our Nation's veterans deserve to be recognized, commended and thanked by the people of the State of New York for their service and for their dedication to their communities, their State and their Nation; now, therefore, be it
