WHEREAS, Throughout his career thus far, Command Sergeant Major Samuel J. Roark has been deployed to Colorado, Texas, Georgia, South Carolina, Hawaii, Kansas, and New York, and abroad in Iraq, Korea, and Afghanistan; and

WHEREAS, During his service, Command Sergeant Major Samuel J. Roark earned his Bachelor of Science degree from Excelsior College and a Master's degree in Leadership and Management from Webster University; and

WHEREAS, Command Sergeant Major Samuel J. Roark is also a graduate of the Bradley Master Gunner Course and each of the United States Army's Professional Education Schools, including the United States Army Sergeant Major Academy; and

WHEREAS, Command Sergeant Major Samuel J. Roark first came to Fort Drum and the North Country in October of 2017; throughout his tenure, he served as a senior manager responsible for developing mid-level managers and leaders capable of accomplishing multiple global missions; and

WHEREAS, In addition to these duties, Command Sergeant Major Samuel J. Roark led overseas training missions, professional development and human resource functions; and

WHEREAS, Under the helm of the chief executive officer of the reservation, Command Sergeant Major Samuel J. Roark also served as a garrison manager and was responsible for the personnel of the 10th Mountain Division, Light Infantry; and

WHEREAS, Throughout his distinguished military career, Command

Sergeant Major Samuel J. Roark has been the recipient of numerous awards including the Legion of Merit, the Bronze Star, the Purple Heart, the Meritorious Service Medal, the Army Commendation Medal, the Navy Achievement Medal, the National Defense Service Medal, the Afghanistan Campaign Medal, the Iraq Campaign Medal and many more; and
