WHEREAS, Under his luminous leadership, the Wyoming County Board of Supervisors has taken part in an aggressive capital improvement program over the past 15 years, replacing and renovating almost all county buildings, and implementing a Better Pavement program in which the County Highway Department performs a total reconstruction of at least 10 miles of road annually; and

WHEREAS, As Town Supervisor, A. Douglas Berwanger was instrumental in the Highway Department's great success in rotating the equipment replacement schedules, and providing a high level of services to Arcade residents in the form of fully paved roads throughout the town, exceptional snow and ice removal, and maintenance; and

WHEREAS, Devoted to his leadership role and his community, A. Douglas Berwanger has served as Deputy Parliamentarian of the New York

State Association of Counties (NYSAC) Board of Directors, and was the President of the NYSAC Chairs of County Legislative Boards; and

WHEREAS, In addition, A. Douglas Berwanger has been a vital member of the Arcade Fire Department for the past 22 years; and
