Introduced by Sen. BRESLIN -- read twice and ordered printed, and when printed to be committed to the Committee on Finance

AN ACT to amend the public officers law, in relation to requiring legislators and candidates for member of the legislature to provide a link to their financial disclosure statements on their official state and campaign websites

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The opening paragraph of paragraph (k) of subdivision 2 of
2 section 73-a of the public officers law is designated subparagraph (i)
3 and two new subparagraphs (ii) and (iii) are added to read as follows:

4 (ii) Notwithstanding any other provision of law to the contrary, all
5 members of the legislature who maintain any state website for service in
6 their official capacity shall establish a clearly visible link entitled
7 "MY FINANCIAL DISCLOSURE STATEMENTS" on the front page of their website
8 which shall direct website visitors to current and past financial
9 disclosure forms that the legislator has submitted to the joint commis-
10 sion on public ethics.

11 (iii) Notwithstanding any other provision of law to the contrary,
12 every candidate for member of the legislature who maintains any website
13 for service in their official campaign capacity shall establish a clear-
14 ly visible link entitled "MY FINANCIAL DISCLOSURE STATEMENTS" on the
15 front page of their campaign website which shall direct visitors to
16 current and past financial disclosure forms that the candidate has
17 submitted to the joint commission on public ethics, in accordance with
18 paragraph (a) of this subdivision.

19 § 2. The opening paragraph of paragraph (a) of subdivision 2 of
20 section 73-a of the public officers law, as amended by section 5 of part
21 A of chapter 399 of the laws of 2011, is amended to read as follows:

22 Every statewide elected official, state officer or employee, member of
23 the legislature, legislative employee and political party chairman and

every candidate for statewide elected office or for member of the legislature shall file an annual statement of financial disclosure containing the information and in the form set forth in subdivision three of this section. Every member of the legislature and candidate for member of the legislature must file their annual statement of financial disclosure electronically in an electronic, readable, searchable and downloadable format. On or before the fifteenth day of May with respect to the preceding calendar year: (1) every member of the legislature, every candidate for member of the legislature and legislative employee shall file such statement with the legislative ethics commission which shall provide such statement along with any requests for exemptions or deletions to the joint commission on public ethics for filing and rulings with respect to such requests for exemptions or deletions, on or before the thirtieth day of June; and (2) all other individuals required to file such statement shall file it with the joint commission on public ethics, except that:

§ 3. Subdivision 3 of section 73-a of the public officers law, as amended by section 5 of part A of chapter 399 of the laws of 2011, paragraph 8 as amended by section 6 of part K of chapter 286 of the laws of 2016 and paragraph 13 as amended by section 1 of part CC of chapter 56 of the laws of 2015, is amended to read as follows:

The disclosure requirement in this question shall not require disclosure of clients or customers receiving medical or dental services, mental health services, residential real estate brokering services, or insurance brokering services from the reporting individual or his or her firm. The reporting individual need not identify any client to whom he or she or his or her firm provided legal representation with respect to investigation or prosecution by law enforcement authorities, bankruptcy, or domestic relations matters. With respect to clients represented in other matters, where disclosure of a client's identity is likely to cause harm, the reporting individual shall request an exemption from the joint commission pursuant to paragraph (i-1) of subdivision nine of section ninety-four of the executive law, provided, however, that a reporting individual who first enters public office after July first, two thousand twelve, need not report clients or customers with respect to matters for which the reporting individual or his or her firm was retained prior to entering public office.

If the reporting individual receives income from employment reportable in question 8(a) and personally provides services to any person or entity, or works as a member or employee of a partnership or corporation that provides such services (referred to hereinafter as a "firm"), the reporting individual shall identify each client or customer to whom the reporting individual personally provided services, or who was referred to the firm by the reporting individual, and from whom the reporting individual or his or her firm earned fees in excess of \$10,000 during the reporting period in direct connection with:

(i) A contract in an amount totaling \$10,000 or more from the state or any state agency for services, materials, or property;

(ii) A grant of \$10,000 or more from the state or any state agency during the reporting period;

(iii) A grant obtained through a legislative initiative during the reporting period; or

(iv) A case, proceeding, application or other matter that is not a ministerial matter before a state agency during the reporting period.

For such services rendered by the reporting individual directly to each such client, describe each matter that was the subject of such representation, the services actually provided and the payment received. For payments received from clients referred to the firm by the reporting individual, if the reporting individual directly received a referral fee or fees for such referral, identify the client and the payment so received.

 27 require disclosing clients or customers receiving medical, pharmaceu-

 29 estate brokering services from the reporting individual or his or her
 30 firm or if federal law prohibits or limits disclosure. The reporting
 31 individual need not identify any client to whom he or she or his or her
 32 firm provided legal representation with respect to investigation or
 33 prosecution by law enforcement authorities, bankruptcy, family court,
 34 estate planning, or domestic relations matters, nor shall the reporting
 35 individual identify individuals represented pursuant to an insurance
 36 policy but the reporting individual shall in such circumstances only
 37 report the entity that provides compensation to the reporting individ-
 38 ual; with respect to matters in which the client's name is required by
 39 law to be kept confidential (such as matters governed by the family
 40 court act) or in matters in which the reporting individual represents or
 41 provides services to minors, the client's name may be replaced with
 42 initials. To the extent that the reporting individual, or his or her
 43 firm, provided legal representation with respect to an initial public

 46 the reporting individual shall (i) disclose the identity of the client

12 otherwise exempt, the reporting individual may request an exemption to
13 publicly disclosing the name of that client from the joint commission
14 pursuant to paragraph (i-1) of subdivision nine of section ninety-four
15 of the executive law, or from the office of court administration. In
16 such application, the reporting individual shall state the following:

29 In reviewing the request for an exemption, the joint commission or the
30 office of court administration may consult with bar or other profes-
31 sional associations and the legislative ethics commission for individ-
32 uals subject to its jurisdiction and may consider the rules of profes-
33 sional conduct. In making its determination, the joint commission or the
34 office of court administration shall conduct its own inquiry and shall
35 consider factors including, but not limited to: (i) the nature and the
36 size of the client; (ii) whether the client has any business before the
37 state; and if so, how significant the business is; and whether the
38 client has any particularized interest in pending legislation and if so
39 how significant the interest is; (iii) whether disclosure may reveal
40 trade secrets; (iv) whether disclosure could reasonably result in retal-
41 iation against the client; (v) whether disclosure may cause undue harm
42 to the client; (vi) whether disclosure may result in undue harm to the
43 attorney-client relationship; and (vii) whether disclosure may result in
44 an unnecessary invasion of privacy to the client.

45 The joint commission or, as the case may be, the office of court
46 administration shall promptly make a final determination in response to
47 such request, which shall include an explanation for its determination.
48 The office of court administration shall issue its final determination
49 within three days of receiving the request. Notwithstanding any other
50 provision of law or any professional disciplinary rule to the contrary,
51 the disclosure of the identity of any client or customer in response to
52 this question shall not constitute professional misconduct or a ground
53 for disciplinary action of any kind, or form the basis for any civil or
54 criminal cause of action or proceeding. A reporting individual who first
55 enters public office after January first, two thousand sixteen, need not
56 report clients or customers with respect to matters for which the

2 public office.

8 If the reporting individual receives income of ten thousand dollars or
9 greater from any employment or activity reportable under question 8(a),
10 identify each registered lobbyist who has directly referred to such
11 individual a client who was successfully referred to the reporting indi-
12 vidual's business and from whom the reporting individual or firm
13 received a fee for services in excess of five thousand dollars. Report
14 only those referrals that were made to a reporting individual by direct
15 communication from a person known to such reporting individual to be a
16 registered lobbyist at the time the referral is made. With respect to
17 each such referral, the reporting individual shall identify the client,
18 the registered lobbyist who has made the referral, the category of value
19 of the compensation received and a general description of the type of
20 matter so referred. A reporting individual need not disclose activities
21 performed while lawfully acting pursuant to paragraphs (c), (d), (e) and
22 (f) of subdivision seven of section seventy-three of this article. The
23 disclosure requirements in this question shall not require disclosing
24 clients or customers receiving medical, pharmaceutical or dental
25 services, mental health services, or residential real estate brokering
26 services from the reporting individual or his or her firm or if federal
27 law prohibits or limits disclosure. The reporting individual need not
28 identify any client to whom he or she or his or her firm provided legal
29 representation with respect to investigation or prosecution by law
30 enforcement authorities, bankruptcy, family court, estate planning, or
31 domestic relations matters, nor shall the reporting individual identify
32 individuals represented pursuant to an insurance policy but the report-
33 ing individual shall in such circumstances only report the entity that
34 provides compensation to the reporting individual; with respect to
35 matters in which the client's name is required by law to be kept confi-
36 dential (such as matters governed by the family court act) or in matters
37 in which the reporting individual represents or provides services to
38 minors, the client's name may be replaced with initials. To the extent
39 that the reporting individual, or his or her firm, provided legal repre-
40 sentation with respect to an initial public offering, and federal law or
41 regulations restricts the disclosure of information relating to such
42 work, the reporting individual shall (i) disclose the identity of the
43 client and the services provided relating to the initial public offering
44 to the office of court administration, who will maintain such informa-
45 tion confidentially in a locked box; and (ii) include in his or her
46 response a statement that pursuant to this paragraph, a disclosure to
47 the office of court administration has been made. Upon such time that
48 the disclosure of information maintained in the locked box is no longer
49 restricted by federal law or regulation, the reporting individual shall
50 disclose such information in an amended disclosure statement in response
51 to the disclosure requirements of this paragraph. The office of court
52 administration shall develop and maintain a secure portal through which
53 information submitted to it pursuant to this paragraph can be safely and
54 confidentially stored. With respect to clients represented in other
55 matters not otherwise exempt, the reporting individual may request an
56 exemption to publicly disclosing the name of that client from the joint

commission pursuant to paragraph (i-1) of subdivision nine of section ninety-four of the executive law, or from the office of court administration. In such application, the reporting individual shall state the following: "My client is not currently receiving my services or seeking my services in connection with:

(i) A proposed bill or resolution in the senate or assembly during the reporting period;

(ii) A contract in an amount totaling \$10,000 or more from the state or any state agency for services, materials, or property;

(iii) A grant of \$10,000 or more from the state or any state agency during the reporting period;

(iv) A grant obtained through a legislative initiative during the reporting period; or

(v) A case, proceeding, application or other matter that is not a ministerial matter before a state agency during the reporting period."

In reviewing the request for an exemption, the joint commission or the office of court administration may consult with bar or other professional associations and the legislative ethics commission for individuals subject to its jurisdiction and may consider the rules of professional conduct. In making its determination, the joint commission or the office of court administration shall conduct its own inquiry and shall consider factors including, but not limited to: (i) the nature and the size of the client; (ii) whether the client has any business before the state; and if so, how significant the business is; and whether the client has any particularized interest in pending legislation and if so how significant the interest is; (iii) whether disclosure may reveal trade secrets; (iv) whether disclosure could reasonably result in retaliation against the client; (v) whether disclosure may cause undue harm to the client; (vi) whether disclosure may result in undue harm to the attorney-client relationship; and (vii) whether disclosure may result in an unnecessary invasion of privacy to the client.

The joint commission or, as the case may be, the office of court administration shall promptly make a final determination in response to such request, which shall include an explanation for its determination. The office of court administration shall issue its final determination within three days of receiving the request. Notwithstanding any other provision of law or any professional disciplinary rule to the contrary, the disclosure of the identity of any client or customer in response to this question shall not constitute professional misconduct or a ground for disciplinary action of any kind, or form the basis for any civil or criminal cause of action or proceeding. A reporting individual who first enters public office after December thirty-first, two thousand fifteen, need not report clients or customers with respect to matters for which the reporting individual or his or her firm was retained prior to entering public office.
