AN ACT to amend the penal law, in relation to sex offenses, prostitution offenses, obscenity offenses and sexual performance by a child offense committed against a minor

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraph (i) of paragraph (a) of subdivision 3 of 2 section 70.00 of the penal law, as amended by chapter 107 of the laws of 3 2006, is amended to read as follows:

4 (i) For a class A-I felony, such minimum period shall not be less than 5 fifteen years nor more than twenty-five years; provided, however, that (A) where a sentence, other than a sentence of death or life imprisonб 7 ment without parole, is imposed upon a defendant convicted of murder in 8 the first degree as defined in section 125.27 of this chapter such mini-9 mum period shall be not less than twenty years nor more than twenty-five 10 years, and, (B) where a sentence is imposed upon a defendant convicted of murder in the second degree as defined in subdivision five of section 11 12 125.25 of this chapter or convicted of aggravated murder as defined in 13 section 125.26 of this chapter, the sentence shall be life imprisonment 14 without parole, and, (C) where a sentence is imposed upon a defendant convicted of attempted murder in the first degree as defined in article 15 one hundred ten of this chapter and subparagraph (i), (ii) or (iii) of 16 paragraph (a) of subdivision one and paragraph (b) of subdivision one of 17 section 125.27 of this chapter or attempted aggravated murder as defined 18 19 in article one hundred ten of this chapter and section 125.26 of this 20 chapter such minimum period shall be not less than twenty years nor more 21 than forty years, and, (D) where a sentence is imposed upon a defendant convicted of rape of a child as defined in section 130.36 of this chap-22 ter, convicted of criminal sexual act against a child as defined in 23 24 section 130.51 of this chapter, convicted of sexual abuse of a child as 25 defined in section 130.64 of this chapter, convicted of aggravated sexu-26 al abuse of a child as defined in section 130.71 of this chapter, 27 convicted of course of sexual conduct against a child in the first

A defendant must be sentenced to life 39 imprisonment without parole upon conviction for the crime of murder in the second degree as defined in subdivision five of section 125.25 of 40 this chapter or for the crime of aggravated murder as defined in subdi-41 42 vision one of section 125.26 of this chapter. A defendant may be 43 sentenced to life imprisonment without parole upon conviction for the 44 crime of aggravated murder as defined in subdivision two of section 45 125.26 of this chapter.
