AN ACT to amend the environmental conservation law, in relation to instituting a moratorium on the distribution, sale or use of glyphosate until a task force completes a study regarding the safety, alternatives and use of such compound

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The environmental conservation law is amended by adding a 2 new section 37-0115 to read as follows:
 - § 37-0115. Prohibition against use of glyphosate.
- 1. No person, firm, partnership, association, limited liability company or corporation shall distribute, sell, offer for sale or use glyphosate or any products containing glyphosate within New York state until July first, two thousand twenty-four.
- 8 2. For the purpose of this section, "glyphosate" shall mean a synthet9 ic compound that is a non-selective systemic herbicide, also known as
 10 N-(phosphonomethyl) glycine with a chemical formula of C3H8NO5P.
- 3. There shall be established within the department a glyphosate task force which shall consist of the following members:
- 13 <u>(a) The commissioner of the department, or the commissioner's desig-</u>
 14 <u>nee.</u>
- 15 <u>(b) The commissioner of the department of health, or such commission-</u> 16 <u>er's designee.</u>
- 17 <u>(c) The commissioner of the department of agriculture and markets, or</u>
 18 <u>such commissioner's designee.</u>
- 19 (d) A representative from the state university of New York's college 20 of environmental science and forestry, appointed by the governor.

- 1 (e) A representative from the New York farm bureau, appointed by the 2 governor.
- 3 (f) A representative from the pesticide industry, appointed by the 4 governor.
- 5 (g) A representative from an environmental organization, appointed by 6 the governor.
 - 4. The task force shall:

- 8 (a) Research and identify any health and safety concerns associated 9 with the use of glyphosate.
 - (b) Identify safe alternatives to glyphosate.
- 11 (c) Determine whether the use of glyphosate should be permitted in the 12 state.
- 13 (d) If the use of glyphosate should be permitted, identify recommended 14 safe practices associated with the use of glyphosate.
- 5. The members of the task force shall serve without compensation,
 except members shall be allowed their necessary and actual expenses
 incurred in the performance of their duties under this section.
- 6. The members of the task force shall submit a report of their findings and recommendations, including any proposed legislation, to the governor and legislature no later than January first, two thousand twenty-four.
- 22 <u>7. The glyphosate task force shall cease to exist on June thirtieth,</u>
 23 two thousand twenty-four.
- 24 § 2. This act shall take effect immediately.
