AN ACT to amend the social services law, in relation to supplemental security income for eligible individuals receiving enhanced residential care

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (e) of subdivision 2 of section 209 of the social  
2 services law, as amended by section 2 of part YY of chapter 59 of the  
3 laws of 2018, is amended to read as follows:

4 (e) (i) [~~On and after~~] (1) From January first, two thousand eighteen  
5 to March thirty-first, two thousand nineteen, for an eligible individual  
6 receiving enhanced residential care, \$1,444.00; and [~~(ii)~~] (2) for an  
7 eligible couple receiving enhanced residential care, two times the  
8 amount set forth in [~~subparagraph (i)~~] clause one of this [~~paragraph~~]  
9 subparagraph.

10 (ii) (1) From April first, two thousand nineteen to March thirty-  
11 first, two thousand twenty, for an eligible individual receiving  
12 enhanced residential care, \$1,564.00; and (2) for an eligible couple  
13 receiving enhanced residential care, two times the amount set forth in  
14 clause one of this subparagraph.

15 (iii) (1) From April first, two thousand twenty to March thirty-first,  
16 two thousand twenty-one, for an eligible individual receiving enhanced  
17 residential care, \$1,684.00; and (2) for an eligible couple receiving  
18 enhanced residential care, two times the amount set forth in clause one  
19 of this subparagraph.

20 (iv) (1) From April first, two thousand twenty-one to March thirty-  
21 first, two thousand twenty-two, for an eligible individual receiving  
22 enhanced residential care, \$1,804.00; and (2) for an eligible couple

3 (v) (1) From April first, two thousand twenty-two to March thirty-  
4 first, two thousand twenty-three, for an eligible individual receiving  
5 enhanced residential care, \$1,924.00; and (2) for an eligible couple  
6 receiving enhanced residential care, two times the amount set forth in  
7 clause one of this subparagraph.

8 (vi) (1) From April first, two thousand twenty-three and thereafter,  
9 for an eligible individual receiving enhanced residential care,  
10 \$2,044.00; and (2) for an eligible couple receiving enhanced residential  
11 care, two times the amount set forth in clause one of this subparagraph.

12 § 2. This act shall take effect April 1, 2019.
