- AN ACT to amend the social services law, in relation to supplemental security income for eligible individuals receiving enhanced residential care

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (e) of subdivision 2 of section 209 of the social services law, as amended by section 2 of part L of chapter 56 of the laws of 2019, is amended to read as follows:

4 (e) [On and after] (i)(1) From January first, two thousand nineteen to
5 March thirty-first, two thousand twenty, [(i)] for an eligible individ6 ual receiving enhanced residential care, \$1,465.00; and [(ii)] (2) for
7 an eligible couple receiving enhanced residential care, two times the
8 amount set forth in [subparagraph (i)] clause one of this [paragraph]
9 subparagraph.

(ii) (1) From April first, two thousand twenty to March thirty-first, two thousand twenty-one, for an eligible individual receiving enhanced residential care, \$1,585.00; and (2) for an eligible couple receiving enhanced residential care, two times the amount set forth in clause one of this subparagraph.

15 <u>(iii) (1) From April first, two thousand twenty-one to March thirty-</u> 16 <u>first, two thousand twenty-two, for an eligible individual receiving</u>

17 enhanced residential care, \$1,705.00; and (2) for an eligible couple
