AN ACT to amend the civil practice law and rules, in relation to certain fees payable to the county clerk

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision (a) of section 8020 of the civil practice law 2 and rules, as amended by section 25 of part J of chapter 62 of the laws 3 of 2003, is amended to read as follows:

- (a) Placing cause on calendar. For placing a cause on a calendar for 5 trial or inquest, one hundred twenty-five dollars in the supreme court and county court; except that where rules of the chief administrator of the courts require that a request for judicial intervention be made in an action pending in supreme court or county court, the county clerk shall be entitled to a fee of ninety-five dollars, payable before a judge may be assigned pursuant to such request, and thereafter, for 10 11 placing such a cause on a calendar for trial or inquest, the county clerk shall be entitled to an additional fee of thirty dollars, and no 12 other fee may be charged thereafter pursuant to this subdivision; except 13 14 that the county clerk shall be entitled to a fee of forty-five dollars 15 upon the filing of each motion or cross motion in such action. However, no fee shall be imposed; 16
 - 1. for a motion which seeks leave to proceed as a poor person pursuant to subdivision (a) of section eleven hundred one of this chapter: or
- 2. for a motion filed by the fiduciary, court evaluator, guardian ad 20 litem, court-appointed attorney or by the court examiner in any guardi-21 anship matter under article eighty-one of the mental hygiene law.
 - § 2. This act shall take effect immediately.
