AN ACT to amend the penal law, in relation to certain controlled substances offenses

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 220.00 of the penal law is amended by adding a new subdivision 21 to read as follows:

- 21. "Knowingly" when used in connection with the offenses involving 4 the possession or sale, or the attempt or conspiracy to possess or sell, a synthetic cannabinoid, synthetic cathinone, or a controlled substance analogue, shall not require knowledge by the defendant of the chemical structure of the substance, but rather, it is sufficient if:
 - (a) the defendant knew or should have known that the substance has a stimulant, depressant, or hallucinogenic effect on the central nervous system that is substantially similar to or greater than the stimulant, depressant, or hallucinogenic effect on the central nervous system of a controlled substance in schedule I or II of section thirty-three hundred six of the public health law; or
- (b) the defendant represented or intended for the substance to have a 15 <u>stimulant</u>, <u>depressant</u>, <u>or hallucinogenic effect on the central nervous</u> 16 system that is substantially similar to or greater than the stimulant, depressant, or hallucinogenic effect on the central nervous system of a controlled substance in schedule I or II of section thirty-three hundred six of the public health law.
- 20 § 2. Subdivision 8 of section 220.06 of the penal law, as added by 21 chapter 264 of the laws of 2003, is amended and a new subdivision 9 is 22 added to read as follows:
- 8. one or more preparations, compounds, mixtures or substances 23 24 containing gamma hydroxybutyric acid, as defined in paragraph four of 25 subdivision (e) of schedule I of section thirty-three hundred six of the

- 9. one or more preparations, compounds, mixtures or substances containing a synthetic cannabinoid as defined in subdivision (q) of schedule I of section thirty-three hundred six of the public health law and said preparations, compounds, mixtures or substances are of an aggregate weight of one ounce or more.
- 9 3. Subdivision 15 of section 220.09 of the penal law, as added by chapter 264 of the laws of 2003, is amended and a new subdivision 16 10 11 added to read as follows:
- 15. one or more preparations, compounds, mixtures or substances containing gamma hydroxybutyric acid, as defined in paragraph four of 14 subdivision (e) of schedule I of section thirty-three hundred six of the public health law, and said preparations, compounds, mixtures or substances are of an aggregate weight of two hundred grams or more[-];
 - 16. one or more preparations, compounds, mixtures or substances containing a synthetic cannabinoid as defined in subdivision (g) of schedule I of section thirty-three hundred six of the public health law and said preparations, compounds, mixtures or substances are of an aggregate weight of four ounces or more.
 - § 4. Subdivision 13 of section 220.16 of the penal law, as amended by chapter 75 of the laws of 1995, is amended and a new subdivision 14 added to read as follows:
 - phencyclidine and said phencyclidine weighs one thousand two hundred fifty milligrams or more[→]; or
 - 14. one or more preparations, compounds, mixtures or substances containing a synthetic cannabinoid as defined in subdivision (g) of schedule I of section thirty-three hundred six of the public health law and said preparations, compounds, mixtures or substances are of an aggregate weight of ten pounds or more.
 - § 5. Subdivision 3 of section 220.34 of the penal law, as amended by chapter 537 of the laws of 1998, is amended and a new subdivision 10 is added to read as follows:
 - 3. concentrated cannabis as defined in [paragraph (a) of] subdivision four of section thirty-three hundred two of the public health law; or
 - 10. one or more preparations, compounds, mixtures or substances containing a synthetic cannabinoid as defined in subdivision (g) of schedule I of section thirty-three hundred six of the public health law and said preparations, compounds, mixtures or substances are of an aggregate weight of one ounce or more.
 - § 6. Subdivision 9 of section 220.39 of the penal law, as added by chapter 410 of the laws of 1979, is amended and a new subdivision 10 is added to read as follows:
- 46 9. a narcotic preparation to a person less than twenty-one years 47 old[→] ; or
- 10. one or more preparations, compounds, mixtures or substances 48 containing a synthetic cannabinoid as defined in subdivision (g) of 49 schedule I of section thirty-three hundred six of the public health law 50 51 and said preparations, compounds, mixtures or substances are of an 52 aggregate weight of sixteen ounces or more.
 - § 7. This act shall take effect November 1, 2019.
