AN ACT to amend the election law, in relation to party committee and constituted committee contribution and receipt limits; and to repeal subdivision 3 of section 14-124 of the election law relating thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 10 of section 14-114 of the 2 election law, as added by chapter 79 of the laws of 1992, is amended to 3 read as follows:

- a. No contributor may make a contribution to a party or constituted committee and no such committee may accept a contribution from any contributor which, in the aggregate, is greater than [sixty two] twenty-five thousand [five hundred] dollars per annum, which shall include all monies received for the purposes of maintaining a permanent head-quarters and staff and for carrying on ordinary activities which are not for the express purpose of promoting the candidacy of specific candidates.
- 12 § 2. Subdivision 3 of section 14-124 of the election law is REPEALED.
- 13 § 3. This act shall take effect immediately.
