AN ACT to amend the elder law, in relation to establishing a veterans' gerontological advisory committee

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The elder law is amended by adding a new section 225 to

8	Members shall serve without salary. Any member chosen to fill a vacancy

10	unexpired term of the member he or she is to succeed. A chairperson and
11	vice-chairperson shall be appointed by the director, and the committee
12	shall be comprised of:

2. Sixty percent of the members of the advisory committee appointed on
and after the effective date of this subdivision shall be sixty years of
age or over.
3. The committee shall provide advice, comments and recommendations to
advise the director on policies, programs, services and trends impacting
the state's aging veteran population and the larger context of veterans'
healthcare systems, and such other matters as the director may request
in relation to this article.
4. The advisory committee shall meet at least once annually at times
and places set by the chairperson.
5. The director may ask other individuals to attend the committee's
meetings or work with it on an occasional or regular basis.
6. Membership on the committee shall not constitute the holding of an
office, and members of the committee shall not be required to take and
file oaths of office before serving on the committee. The committee
shall not have the right to exercise any portion of the sovereign powers
of the state.
7. No member of the committee shall be disqualified from holding any
public office or employment, nor shall he or she forfeit any such office
or employment, by reason of his or her appointment hereunder, notwith-
standing the provisions of any general, special or local law, ordinance
or city charter.
8. For the purposes of this section, the term "veteran" means a
person, male or female, resident of this state, who has served in the
active military or naval service of the United States during a war in
which the United States engaged and who has been released from such
service by any means other than by dishonorable discharge, or who has
been furloughed to the reserve.
