AN ACT to amend the education law, in relation to requiring public and private colleges and universities to provide all incoming and current students with information about depression and suicide prevention and resources available to them on campus

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative intent. The legislature hereby finds and 2 declares that there is a need to address the growing number of students at the collegiate level who are suffering from psychiatric stressors 3 that may lead to suicide. The legislature further recognizes that such 4 5 psychiatric stressors also contribute to difficulties in learning and б success on the collegiate level. Early detection and identification of at-risk individuals may not only prevent suicide, but may also allow 7 8 such other students suffering from psychiatric stressors to get the support needed to be successful in their academic endeavors. The support 9 10 necessary to achieve these goals may often require collaboration between 11 college officials and parents and/or guardians in such a manner as to be 12 consistent with the needs of each student.

13 Therefore, to achieve the above-stated goals, the legislature hereby 14 finds and declares that every college within the state shall establish a 15 suicide prevention program.

16 § 2. The education law is amended by adding a new section 6438-a to 17 read as follows:

18 <u>§ 6438-a. The collegiate suicide prevention program. 1. The trustees</u> 19 <u>or governing board of each college shall inform incoming students about</u> 20 <u>suicide prevention measures through programs which may include work-</u> 21 <u>shops, seminars, discussion groups, and film presentations, in order to</u>

1	disseminate information about pressures and matters that may place a
2	person at risk of suicide, promote discussion, encourage reporting of
3	persons at risk of suicide, and facilitate prevention of such incidents.
4	Such information shall include, but not be limited to:
5	a. the mental health services available to students,
б	<u>b. how to identify an at risk person,</u>
7	c. the procedures in effect at the college for dealing with attempted
8	suicide,
9	d. the availability of counseling and other support services for
10	persons at risk and those affected by suicide,
11	e. the nature of and common circumstances relating to suicide on
12	college campuses, and
13	f. the methods the college employs to support at risk students.
14	2. Pursuant to the requirements set forth in subdivision one of this
15	section, each college shall file a report annually on its compliance of
16	such program with the commissioner.
17	3. If the trustees or other governing board of a college fails to file
18	the rules and regulations within the time required by this section such
19	college shall not be eligible to receive any state aid or assistance
20	until such rules and regulations are duly filed.
21	4. a. The president or chief administrative officer of each college,
22	except those independent colleges ineligible to receive state aid under
23	section sixty-four hundred one of this title, which maintains a campus
24	and is chartered by the regents or incorporated by special act of the
25	legislature shall appoint an advisory committee on mental health.
26	b. Such committee shall consist of a minimum of six members, one indi-
27	vidual shall be a professional in the area of mental health, at least
28	one member shall be an employee of the campus based medical facility,
29	two members of the committee shall be appointed from a list of students
30	that are participants in the student governance organization on such
31	campus, and at least two members shall be appointed from a list of
32	faculty members. All appointments shall be made by the president or
33	chief administrative officer of the college.
34	c. The committee shall review current campus mental health policies
35	and procedures and make recommendations for their improvement. It shall
36	specifically review current policies and procedures (1) for educating
37	the campus community, including mental health and medical personnel and
38	those persons who advise or supervise students, about mental health
39	issues pursuant to subdivision one of this section, (2) for educating
40	the campus community about mental health issues and suicide prevention,
41	(3) for reporting persons in crisis and dealing with persons in need,
42	(4) for referring individuals in crisis to appropriate professionals,
43	(5) for counseling individuals, and (6) for responding to inquiries from
44	concerned persons.

1 § 3. This act shall take effect on the first of July next succeeding 2 the date on which it shall have become a law. Effective immediately, the 3 addition, amendment and/or repeal of any rule or regulation necessary 4 for the implementation of this act on its effective date are authorized 5 to be made and completed on or before such effective date.
