- AN ACT to amend chapter 192 of the laws of 2011, relating to authorizing certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, in relation to including the World Triathlon Corporation and extending the provisions thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Chapter 192 of the laws of 2011, relating to authorizing 2 certain health care professionals licensed to practice in other juris-3 dictions to practice in this state in connection with an event sanc-4 tioned by New York Road Runners, as amended by chapter 69 of the laws of 5 2018, is amended to read as follows:

Section 1. Notwithstanding any inconsistent provision of law, any 6 7 person who is licensed to practice as a physician, physician's assist-8 ant, massage therapist, physical therapist, chiropractor, dentist, opto-9 metrist, nurse, nurse practitioner, emergency medical technician, certi-10 fied athletic trainer or podiatrist in another state or territory, who is in good standing in such state or territory and who has been 11 appointed by the New York Road Runners or World Triathlon Corporation to 12 provide professional services at an event in this state sanctioned by 13 14 the New York Road Runners or World Triathlon Corporation, may provide 15 such professional services to athletes and team personnel registered to 16 train at a location in this state or registered to compete in an event conducted under the sanction of the New York Road Runners or World 17 18 **Triathlon Corporation** in the state without first being licensed pursuant 19 to the provisions of title 8 of the education law.
