KAPLAN -- read twice and ordered printed, and when printed to be committed to the Committee on Racing, Gaming and Wagering -- reported favorably from said committee, ordered to first and second report, ordered to a third reading, amended and ordered reprinted, retaining its place in the order of third reading

AN ACT to amend the racing, pari-mutuel wagering and breeding law, in relation to the composition of the local advisory board for the Belmont racetrack facility

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 6 of section 212 of the racing, pari-mutuel  
2 wagering and breeding law, as added by chapter 18 of the laws of 2008,  
3 is amended to read as follows:

4 6. Within thirty days following the appointment of the members of the  
5 franchise oversight board, the members of the oversight board shall  
6 establish a local advisory board for each racing operation comprised of  
7 the following members to meet at least twice yearly:

8 a. The local advisory board for the Saratoga racetrack facility shall  
9 be comprised of fifteen members and include five designees from each of  
10 the following: the board of supervisors, the mayor of the city of Sara-  
11 toga and the franchised corporation.

12 b. The local advisory board for the Aqueduct racetrack facility shall  
13 be comprised of fifteen members, nine of whom shall be designees of New  
14 York City Queens Community Board Ten, three designees of the franchised  
15 corporation and three designees of the video lottery gaming operator.

16 c. The local advisory board for the Belmont racetrack facility shall  
17 be comprised of seventeen members, six of whom shall be designees of  
18 Nassau County, of whom two shall be residents of Elmont, three designees  
19 of the franchised corporation, two designees of New York City Queens  
20 Community Board Thirteen, and include two designees from each of the

1 following: village of Floral Park, the speaker of the assembly and the  
2 temporary president of the senate.

3 The members of the local advisory boards shall serve for a period of  
4 two years. In the event of a vacancy occurring during a term of appoint-  
5 ment by reason of death, resignation, disqualification or otherwise such  
6 vacancy shall be filled for the unexpired term in the same manner as the  
7 original appointment. The members of the local advisory board shall  
8 serve without compensation, except that each member shall be allowed the  
9 necessary and actual expenses incurred in the performance of his or her  
10 duties pursuant to this section.

11 § 2. This act shall take effect immediately and shall not affect the  
12 repeal of such section and shall be deemed repealed therewith.
