AN ACT to amend the administrative code of the city of New York, in relation to requiring contracts for a commercial lease

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Title 22 of the administrative code of the city of New York is amended by adding a new chapter 12 to read as follows:

CHAPTER 12

22-1202 Commercial lease contract requirements.

- § 22-1201 Definitions. As used in this chapter the following terms have the following meanings:
- 8 9 1. "Written contract" means a commercial lease or lease for the 10 purposes of renting a commercial property, that shall be provided to a 11 commercial tenant as an official agreement on contract terms.
- 2. "Commercial tenant" means a lessee or entity that is entering an 12 13 agreement to rent and lawfully occupy the commercial property.
- 14 3. "Commercial lease" means a written contract provided on paper or 15 <u>electronically</u>.
- 4. "Commercial property" means any non-residential real estate proper-17 ty that is owned or used for business purposes.
- 5. "Property owner" means a person, landlord, owner, or entity that 19 <u>owns or manages a commercial property.</u>
- 20 § 22-1202 Commercial lease contract requirements. 1. A landlord shall 21 provide a written contract to a commercial tenant. Such written contract 22 <u>must include</u>, but is not limited to, the:
 - a. address of the property and a description of the space leased;
- b. contact information for the property owner or manager and the 24 25 primary contact of the business, all contacts preferred by those parties

- 1 <u>should be included on the lease, which shall not be limited to only one</u> 2 contact;
- 3 <u>c. term of the lease, with the date of commencement and date of termi-</u> 4 <u>nation of such term;</u>
- 5 <u>d. lease extension or renewal information if any renewal option is</u>
 6 <u>provided with the date or dates on which such extension or renewal are</u>
 7 <u>exercisable;</u>
 - e. monthly rent and due date;

- 9 <u>f. any terms that may result in termination of the written contract or</u> 10 <u>additional fees and charges;</u>
- g. explanation of any additional fees or charges, if any, such as contribution to property taxes, whether this is consecutive or a one-time payment; and
- 14 <u>h. all the responsibilities for the commercial tenant and the land-</u>
 15 <u>lord, if any.</u>
- 2. Commercial tenants may request that the start date of tenancy or other relevant information to prove occupancy and duration thereof be included or excluded in a written contract.
- 3. Commercial tenants have the right to, upon request, receive any information listed under subdivision one of this section.
- 21 <u>4. Commercial tenants who do not receive a written contract including</u>
 22 <u>items required by this section shall be legally allowed to:</u>
- 23 a. continue their tenancy until the contract is provided;
- 24 b. withhold rent payment after thirty days without a contract; and
- 25 <u>c. suspend payment on the sixty-first day without a lease. Property</u>
 26 <u>owners who do not provided a lease within sixty days forfeit the</u>
- 27 payments for that time period prior and until the issuance of the lease.
- 28 § 2. This act shall take effect immediately.
