AN ACT authorizing the alienation of certain parklands in the town of Southampton, county of Suffolk

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the town of South-2 ampton in the county of Suffolk, acting by and through its governing 3 body and upon such terms and conditions as determined by such board is 4 hereby authorized to discontinue as parklands and alienate the lands described in section three of this act, for the purpose of allowing such 6 board to select new lands to be dedicated as parklands in replacement thereof.

- § 2. The authorization contained in section one of this act shall take effect only upon the condition that the town of Southampton shall dedicate an amount equal to or greater than the fair market value of the 11 parklands being discontinued toward the acquisition of new parklands and/or toward capital improvements to existing parkland and recreational facilities.
- § 3. The parklands authorized by section one of this act to be alien-14 15 ated are described as follows:

ALL that certain plot, piece or parcel of land, with the buildings and 17 improvements thereon erected, situate, lying and being at Tuckahoe, Town 18 of Southampton, County of Suffolk and State of New York, being bounded and described as follows: 19

20 BEGINNING at a point the following three (3) courses and distances 21 from the corner formed by the intersection of the easterly side of 22 Magee Street and the southerly side of North Highway (C.R. 39):

1. South 24 degrees 26 minutes 30 seconds East, 139.49 feet to a 23 24 point;

1 2. South 16 degrees 54 minutes 46 seconds East, 163.81 feet to a point;

- 3. South 16 degrees 58 minutes 35 seconds East, 50.93 feet to the true 4 point or place of BEGINNING;
- 5 RUNNING THENCE along lands now or formerly of Pinill Corp. the follow-6 ing five (5) courses and distances:
- 7 1. North 62 degrees 03 minutes 05 seconds East, 163.94 feet to a 8 point;
- 9 2. North 56 degrees 11 minutes 10 seconds East, 244.57 feet to a 10 point;
- 11 3. Along an arc of a curve bearing to the right having a radius of 12 100.00 feet and an arc length of 67.10 feet to a point;
 - 4. South 85 degrees 22 minutes 16 seconds East, 52.13 feet to a point;
- 5. Along an arc of a curve bearing to the left having a radius of 15 100.00 feet and an arc length of 102.01 feet to a point;
- 16 THENCE along lands now or formerly of The Zucherro Family Irrevocable 17 Trust and S&M Press, Inc. the following two (2) courses and distances:
- 18 1. South 83 degrees 47 minutes 46 seconds East, 234.28 feet to a 19 stake;
- 20 2. South 81 degrees 59 minutes 06 seconds East, 35.92 feet to a 21 concrete monument;
- THENCE South 06 degrees 24 minutes 14 seconds West, 492.50 feet to a concrete monument;
- 24 THENCE along lands now or formerly of Hattrick the following four (4) 25 courses and distances:
- 1. North 40 degrees 58 minutes 15 seconds West, 23.69 feet to a concrete monument;
- 28 2. North 34 degrees 38 minutes 45 seconds West, 99.10 feet to a 29 concrete monument;

- 35 § 4. In the event that the town of Southampton received any funding 36 support or assistance from the federal government for the purchase, maintenance or improvement of the parklands set forth in section three 37 of this act, the discontinuance and alienation of such parklands author-38 ized by the provisions of this act shall not occur until the town of 39 Southampton has complied with any federal requirements pertaining to the 40 41 alienation or conversion of parklands, including satisfying the secretary of the interior that the alienation or conversion complies with all 43 conditions which the secretary of the interior deems necessary to assure 44 the substitution of other lands shall be equivalent in fair market value and usefulness to the lands being alienated or converted. 45
 - § 5. This act shall take effect immediately.
