AN ACT to amend the public health law, in relation to prohibiting the sale and distribution of flavored tobacco products and accessories

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The public health law is amended by adding a new section 1399-cc-1 to read as follows:

§ 1399-cc-1. Sale and distribution of flavored tobacco products and accessories prohibited. 1. For the purposes of this section, the term "characterizing flavor" shall mean a distinguishable taste or aroma, other than the taste or aroma of tobacco, imparted either prior to or during consumption of a tobacco product, including but not limited to, tastes or aromas relating to any fruit, chocolate, vanilla, honey, candy, cocoa, dessert, alcoholic beverage, mint, wintergreen, herb, spice, or menthol, or any concept flavor that imparts a taste or aroma that is distinguishable from tobacco flavor but may not relate to any particular known flavor.

2. No person, firm, partnership, association, limited liability company, corporation, or other entity shall sell, offer for sale, or distribute tobacco products with a characterizing flavor or accessories that impart a characterizing flavor to a tobacco product in this state.

3. Any person, firm, partnership, association, limited liability company, corporation, or other entity other than a manufacturer that violates the provisions of this section shall be subject to a fine of not more than one hundred dollars for each individual tobacco product or accessory with a characterizing flavor that is found to have been sold,

14 section has occurred.

15 4. Notwithstanding any law to the contrary, no enforcement agent,
16 police officer, peace officer or other law enforcement officer may stop,
17 question, search or arrest any person: (a) on grounds of or in relation
18 to possession, consumption or purchase of any product subject to this
19 section; or (b) for the purpose of inquiring or determining how or from
20 what person or entity the person obtained any product subject to this
21 section.

22 § 2. This act shall take effect on the ninetieth day after it shall
23 have become a law. Effective immediately, the addition, amendment
24 and/or repeal of any rule or regulation necessary for the implementation
25 of this act on its effective date are authorized to be made and
26 completed on or before such effective date.
