AN ACT to amend the elder law, in relation to establishing an Alzheimer's disease outreach and education program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The elder law is amended by adding a new section 225 to
2	read as follows:
3	§ 225. Alzheimer's disease outreach and education program. 1. The
4	office, in consultation with the commissioner of health, is hereby
5	authorized and directed to establish an Alzheimer's disease outreach and
6	education program ("the program") for medical and non-medical profes-
7	sionals, including physicians, nurses, and social services personnel who
8	work with older New Yorkers and their families, and for consumers, care-
9	givers and other individuals and organizations working with or on behalf
10	of persons with Alzheimer's disease and related dementia. The purpose of
11	the program shall be to:
12	(a) promote earlier identification of dementia in health care facili-
13	ties including but not limited to hospitals, nursing homes, clinics, and
14	assisted living facilities;
15	(b) provide information and assistance on where to find community
16	support services, including caregiver support groups and services,
17	respite, care management and to serve as a clearinghouse for related
18	information; and
19	(c) promote public awareness of and access to resources and informa-
20	tion concerning Alzheimer's disease and any other dementia related
21	matters that the commissioner and director of the office for the aging
22	<u>deem appropriate.</u>
23	2. The program shall include but shall not be limited to any of the
24	following elements:
25	(a) educational and informational materials in print, audio, visual,
26	<u>electronic or other media;</u>
27	(b) training curriculum including best practices for institutions of
28	higher learning and for ongoing in-service training;

1	(c) public service announcements and advertisements; and
2	(d) establishment of toll-free telephone hotlines and electronic
3	services to provide information.
4	3. The office shall produce, make available to others for reprod-
5	uction, or contract with others to develop materials mentioned in this
б	section as the director deems appropriate. These materials shall be made
7	available to the public free of charge as appropriate or for a fee under
8	certain circumstances. The director may request the commissioner of
9	health to require any health care provider to make these materials
10	available to patients where appropriate and encourage non-medical
11	professionals to make them available to the clients they serve.
12	4. In exercising any of his or her powers under this section, the
13	director shall consult with appropriate health care professionals and
14	providers, senior service providers, organizations representing persons
15	with dementia or cognitive impairments, consumers and patients or organ-
16	izations representing them.
17	5. The director shall ensure that all information and materials
18	produced under this section are maintained and updated to reflect best
19	practice recommendations and are culturally and linguistically appropri-
20	ate for the communities served by the Alzheimer's disease outreach and
21	education program. The office shall post electronic copies of outreach
22	material, including best practices, on its website. The department of
23	health shall post the same information on its website.
24	6. The director may appoint advisory councils relating to various
25	matters under this section. All such councils shall include represen-
26	tation of health care professionals, providers, senior service provid-
27	ers, organizations representing persons with dementia or cognitive
28	impairments, consumers, patients and other appropriate interests. The
29	members of the councils shall receive no compensation for their
30	services, but shall be allowed their actual and necessary expenses
31	<u>incurred in performance of their duties.</u>
32	7. In addition to state funds appropriated under this section, the
33	director may accept grants from public or private sources. The director,
34	in administering this section, shall seek to coordinate programs and
35	activities under this section with other public and private programs,
36	and may undertake joint or cooperative programs with other public or
37	private entities.
38	8. The director may make rules and regulations necessary and appropri-
