AN ACT to amend the social services law and the public health law, relation to medication for the treatment of substance use disorders

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 2 of section 365-a of the social services law 1 is amended by adding a new paragraph (gg) to read as follows:

(qq) all buprenorphine products, methadone or long acting injectable 4 <u>naltrexone for detoxification or maintenance treatment of a substance</u> use disorder prescribed according to generally accepted national professional quidelines for the treatment of a substance use disorder. Such medication assisted treatment shall not be subject to any prior authorization mandate.

§ 2. Subdivision 26-b of section 364-j of the social services law, as 9 10 added by section 4 of part B of chapter 69 of the laws of 2016, is 11 amended to read as follows:

26-b. Managed care providers shall not require prior authorization for [an initial or renewal prescription for buprenorphine or injectable 14 naltremone for detemification or maintenance treatment of opioid addiction unless the prescription is for a non-preferred or non-formu-16 lary form of the drug or as otherwise required by section 1927(k)(6) of 17 the Social Security Act any buprenorphine products, methadone or long 18 acting injectable naltrexone for detoxification or maintenance treatment 19 of a substance use disorder prescribed according to generally accepted national professional guidelines for the treatment of a substance use disorder.

§ 3. Subdivision 10 of section 273 of the public health law, as added 22 23 by section 5 of part B of chapter 69 of the laws of 2016, is amended to 24 read as follows:

10. Prior authorization shall not be required for [an initial or 26 renewal prescription for buprenorphine or injectable naltrexone for 27 detoxification or maintenance treatment of opioid addiction unless the 28 prescription is for a non-preferred or non-formulary form of such drug

§ 4. This act shall take effect on the ninetieth day after it shall have become a law; provided, however, that the amendments to subdivision 26-b of section 364-j of the social services law made by section two of this act shall not affect the repeal of such section, and shall be deemed repealed therewith.
