AN ACT to amend the environmental conservation law and the state finance law, in relation to enacting the "food service packaging recycling funding act"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "food service packaging recycling funding act".

3 § 2. Legislative intent. Recognizing that most food service packaging
4 is not recycled or composted with the state's existing infrastructure,
5 it is the intent of the legislature to provide sustainable funding to
6 increase infrastructure investment for the diversion of food service
7 packaging materials from disposal, assist in establishing domestic end-
8 use markets for recovered food service packaging materials and reduce
9 litter and marine debris attributable to food service packaging materi-
10 als.

11 § 3. Article 27 of the environmental conservation law is amended by
12 adding a new title 30 to read as follows:

TITLE 30

FOOD SERVICE PACKAGING RECYCLING FUNDING ACT

Section 27-3001. Definitions.

§ 27-3001. Definitions.

21 For the purpose of this title, "food service packaging" shall mean a
22 product used for serving or transporting prepared, ready-to-consume food
23 or beverages, including but not limited to, plates, bowls, cups, trays,
24 and hinged or lidded containers. Such definition shall not include
25 beverage containers or single-use disposable items, including but not
26 limited to, plastic bags or single-use packaging for unprepared foods.

27 § 27-3003. Food service packaging recycling fees.

1 1. Advanced recycling fee. An advanced recycling fee is hereby imposed
2 at a rate of three-tenths of one cent per container on all food service
3 packaging provided by a manufacturer or distributor at the first point
4 of sale in the state. Such fee shall be collected by the department and
5 deposited into the food service packaging recycling fund established
6 pursuant to section ninety-two-ii of the state finance law.

7 2. Revenue disbursement. (a) Monies collected pursuant to this section
8 shall be used by the department exclusively for the following purposes:

9 (i) to create and enhance the collection, sortation and processing
10 infrastructure for food service packaging material recycling, including
11 but not limited to, providing financial assistance to site new or to
12 expand existing recycling operations, increasing in-state material proc-
13 essing capabilities and creating markets for recycled-content products
14 and the use of collected food service packaging as feedstock in the
15 production of new products; and

16 (ii) to provide financial assistance to local governments to assist in
17 recycling education and litter cleanup and reduction.

18 (b) The department shall not utilize more than five percent of the
19 monies collected pursuant to this section for administrative purposes.

20 § 27-3005. Recovery rates.

21 No later than July first, two thousand twenty-four, the department
22 shall determine the recycling and recovery rates for food service pack-
23 aging sold in the state. If the recycling of such food service packaging
24 has not achieved a twenty-five percent recycling or recovery rate, the
25 advanced recycling fee, pursuant to subdivision one of section 27-3003
26 of this title, shall increase to five-tenths of one cent per container
27 on January first, two thousand twenty-five.

28 § 27-3007. Advisory council.

29 1. The department shall create a food service packaging material recy-
30 cling advisory council to advise the department on how to most effi-
31 ciently implement the provisions of this title.

32 2. The council shall consist of fifteen individuals and will meet at
33 least quarterly. The council shall annually select a chairperson from
34 its membership. Membership shall include representatives from the
35 following: local governments, recyclers, material recovery facility
36 operators, waste haulers, environmental organizations, restaurants, food
37 service packaging manufacturers or suppliers, and users of recycled
38 materials.

39 § 27-3009. Exclusions.

40 Any city and any county, other than a county wholly within such a
41 city, which implements or enforces a local law, ordinance or resolution
42 prohibiting the use, sale or distribution of any food service packaging
43 that was adopted after January first, two thousand nineteen, shall not
44 be eligible to receive any monies collected pursuant to this title.

45 § 4. The state finance law is amended by adding a new section 92-ii to
46 read as follows:

47 § 92-ii. Food service packaging recycling fund. 1. There is hereby
48 established in the joint custody of the state comptroller and the
49 commissioner of taxation and finance a special fund to be known as the
50 "food service packaging recycling fund".

51 2. Such fund shall consist of all revenue collected from advanced
52 recycling fees pursuant to section 27-3003 of the environmental conser-
53 vation law and any cost recoveries or other revenues collected pursuant
54 to title thirty of article twenty-seven of the environmental conserva-
55 tion law, and any other monies deposited into the fund pursuant to law.

1 3. Monies of the fund, following appropriation by the legislature,
2 shall be used for food service packaging material recycling pursuant to
3 title thirty of article twenty-seven of the environmental conservation
4 law, and expended for the purposes as set forth in section 27-3003 of
5 the environmental conservation law.

6 § 5. This act shall take effect immediately.
